I'm writing to seek the Sydney North Planning Panel's (Panel) electronic approval to exhibit the planning proposal (PP-2021-2926) that seeks to amend the North Sydney Local Environmental Plan (LEP) 2013 to facilitate the development of a mixed use 8-10 storey development, delivering 37 additional dwellings and 23 additional jobs.

On 12 July 2022, the Panel determined that the planning proposal should proceed to Gateway and on 1 August 2022, the Panel appointed itself as the planning proposal authority. The Department issued a Gateway Determination on 28 October 2022 (attached). Since this time, the proponent has updated the planning proposal in accordance with the Gateway conditions. An assessment against the Gateway Determination has been undertaken (see attached). The Department is satisfied that the planning proposal and supporting documents have been amended to satisfy the conditions of the Gateway Determination and the planning proposal can be placed on to public exhibition.

Should the Panel approve, the Agile Planning team will carry out the exhibition on behalf of the Panel in accordance with the Gateway conditions. The draft exhibition material is attached (Exhibition Package - Panel) although the dates may change depending on Panel approval and lead in times for mail outs. To meet the conditions of the Gateway, the proposal needs to go on exhibition this year.

As part of the public exhibition, the Department will:

- send out notification letters and factsheets to surrounding neighbours,
- manage a webpage on the NSW Planning Portal,
- provide contact details for nominated Department staff to answer phone enquiries, and
- consult with State agencies as outlined by the Gateway Determination.

A notification letter and factsheet **(attached)** has been prepared in accordance with the LEP Making Guidelines 2022 and will be distributed by the Department.

Following the exhibition, the Agile Planning team will review the submissions and provide a post-exhibition submissions report, which the Panel may forward to the Department in its request to finalise the planning proposal.
