## **Public Exhibition of Planning Proposal – Pondicherry Precinct (PP/2021/4/1)**

Council is seeking comments from **Transgrid** on a Planning Proposal for the Pondicherry Precinct. The Pondicherry Precinct, located immediately north of Oran Park within the South West Growth Area, .

The proposal seeks to facilitate a new residential precinct comprising of up to 2,850 dwellings (approximately) to accommodate an estimated population of 8,830 people (approximately), a lake, district sports facilities, a Kindergarten to Year 6 public school, Kindergarten to Year 12 private school and an integrated neighbourhood/community centre.

### **The Proposal**

The proposal seeks to rezone Pondicherry from RU1 Primary Production Primary Production under the Camden Local Environmental Plan 2010 (Camden LEP 2010) to R2 Low Density Residential, R3 Medium Density Residential, B1 Neighbourhood Centre, RE1 Public Recreation, SP2 Infrastructure and C2 Environmental Conservation under the State Environmental Planning Policy (Precincts – Western Parkland City) 2021 (Precincts SEPP).

The proposal is accompanied by proposed amendments to Schedule 7 of the Camden Growth Centre Precincts Development Control Plan (draft DCP). The amendments include an Indicative Layout Plan (draft ILP, site specific figures and associated controls for Pondicherry.

Amendments are also proposed to the Oran Park ILP and SEPP maps to address interface and integration issues between Oran Park and Pondicherry Precincts, including proposed amendments to the Oran Park DCP (draft DCP).
