Planning Proposal to heritage list 207 Eastern Road, Wahroonga

At its meeting of 16 December 2020, Council considered a report for the inclusion of 207 Eastern Road, Wahroonga as a local heritage item under the Ku-ring-gai Local Environmental Plan 2015.

As a result of that report, Council resolved the following:

- A. Council adopt the planning proposal to amend the KLEP 2015 to include the allotment described as Lot B, DP414327 containing Laverty House 207 Eastern Road, Wahroonga as a proposed heritage item in Schedule 5 and on the Heritage Map.
