## Re: Supporting Information relating to Bushfire Protection - Planning Proposal Draft Amendment to Lake Macquarie Local Environmental Plan 2014

Following a request for information from New South Wales Rural Fire Service this letter and supporting three bushfire assessments addresses bushfire planning review of Planning Proposal Draft Amendment to Lake Macquarie Local Environmental Plan 2014.

The redacted request from New South Wales Rural Fire Service and subject land descriptors is detailed below:

"The NSW RFS holds no objection to the Planning Proposal, subject to a bush fire consultant's report detailing compliance with the strategic planning provisions detailed in Chapter 4 of Planning for Bush Fire Protection 2019.

In particular, the bush fire consultant's report should consider Items 2, 3 and 7 to determine if proposed rezonings or future revegetation of areas identified in these Items would lead to a worse bush fire protection outcome for the surrounding existing residential development".

Item 7: 350A Old Pacific Highway, Swansea – Comment:

The subject land is vegetated forest zoned C2 Environmental Conservation with no change to zoning proposed. The intent of the planning proposal addresses removal of this property from council's Land Reservation Acquisition map. The land is presently owned by Transport for NSW with the removal of the property from the acquisition map not resulting in increased bush fire risk or zoning change.
