Re: Request for Gateway Determination – PP-B/2021 Planning Proposal for Waverley Affordable Housing Contributions Scheme

On 13 April 2021, Waverley Council resolved to prepare and forward the attached Planning Proposal (the Proposal) to the Department of Planning, Industry and Environment for a Gateway Determination. The Proposal seeks to:

• Amend the Waverley Local Environmental Plan 2012 by adding 6.13 Affordable housing as a new clause to Part 6 Additional Local Provisions

This amendment is a legislative requirement of Section 7.32 Environmental Planning and Assessment Act 1979 (EP&A Act) to impose an affordable housing condition on developments specified in the *Waverley Affordable Housing Contribution Scheme* (AHCS).

Council requests the role of local plan-making authority to exercise the delegations issued by the Minister under Section 3.36 of the *Environmental Planning & Assessment Act 1979* in relation to the making of the amendment.

The planning proposal has been prepared under Part 3 of the *Environmental Planning and Assessment Act 1979* and in accordance with the requirements set out in the Department's "A guide to preparing local environmental plans" and "A guide to preparing planning proposals".
