Dear Mr Bascomb,

Planning proposal to amend Palerang Local Environmental Plan 2014

I am writing in response to your Council's letter dated 7 April 2015 requesting a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* ("EP&A Act") in respect of the planning proposal to rezone land at North Bungendore from RU1 Primary Production to R2 Low Density Residential and RE1 Public Recreation zones.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed the planning proposal's inconsistencies with s117 Directions 1.2 Rural Zones, 1.3 Mining, Petroleum Production and Extractive Industries, 1.5 Rural Lands, 3.2 Caravan Parks and Manufactured Home Estates and 6.2 Reserving Land for Public Purposes are justified by the planning proposal's consistency with the Bungendore Land Use Strategy and Structure Plan 2010, or are of minor significance. No further approval is required in relation to these Directions.

Council is required to further demonstrate the proposal's consistency with s117 Directions 2.1 Environment Protection Zones and 2.3 Heritage Conservation. This should be done after consultation with relevant public authorities.

Council should also ensure that draft maps of a suitable scale and clarity are made available during consultation on the planning proposal.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has now accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within **24 months** of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's

Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2015_PALER_003_00) to rezone land at North Bungendore from RU1 Primary Production to R2 Low Density Residential and RE1 Public Recreation zones.

- I, the General Manager, Southern Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning & Assessment Act 1979* ("EP&A Act") that an amendment to the Palerang Local Environmental Plan (LEP) 2014 to rezone land at North Bungendore from RU1 Primary Production to R2 Low Density Residential and RE1 Public Recreation zones should proceed subject to the following conditions:
- 1. Community consultation is required under sections 56(2)(c) and 57 of the *Environmental Planning and Assessment Act 1979* ("EP&A Act") as follows:
- (a) the planning proposal must be made publicly available for a minimum of 28 days; and
- (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning and Environment 2013).
- 2. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act and/or to comply with the requirements of relevant S117 Directions:
- NSW Office of Environment and Heritage.
- Commonwealth Department of the Environment,
- NSW Rural Fire Service,
- NSW Roads and Maritime Services,
- Transport for NSW,
- NSW Office of Water.
- NSW Environmental Protection Authority,
- Fire and Rescue NSW.
- NSW Department of Education and Communities,
- NSW Police,
- NSW Health,
- Ambulance Service of NSW, and
- NSW State Emergency Service.

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

- 3. Council must undertake the studies identified in the planning proposal prior to undertaking community consultation and must include a copy of the studies in the exhibition materials.
- 4. Council must ensure any potential for land use conflict with the Bungendore waste transfer station as a consequence of the planning proposal has been appropriately addressed.
- 5. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
