Planning Proposal application in respect of 2 Kamira Avenue, Villawood

I wish to acknowledge that a preliminary assessment of the documentation uploaded to the NSW Planning Portal has revealed the application is satisfactory for lodgment to Council pending payment.

An initial review of the application has identified the need for additional information and peer reviews to be undertaken.

Area Map

In completing the preliminary assessment of this Planning Proposal, Council requires the applicant to submit further detailed survey map or an area map of the exact location of the proposed additional uses on the site. As the additional uses do not apply to the entire site, Council is required to assess the proposed location.

Economic Peer Review

The Town Centre Retail Demand Assessment will be required to be peer reviewed by Council's Economic Consultant. A fee quote has been requested from Council's consultant (see attachment A), with the cost to be covered by the applicant, in accordance with Council's fees and charges.

Traffic Peer Review

It is noted that the material submitted does not address the traffic implications of introducing the retail and business uses to the site or access arrangements for the development.

To adequately address the traffic issues, the following will be required:

- a. Traffic Impact Assessment and SIDRA modelling outlining the impact of the proposal for key intersections. This will be peer reviewed at the applicants costs by Council's Traffic Consultants; OR
- b. A brief Traffic Impact Assessment to be prepared with the details of the proposal to be assessed through Council's Mesoscopic Traffic Model. This will also be at the applicants cost, however requires less up initial analysis by the applicant.

Once the applicant has made a decision about which Traffic option will be taken above, Council will request a fee quote from Council's consultant and the review can commence.

<u>Timing</u>

Please be aware that all NSW Council's will be in a caretaker period for 1 month prior to the September local government elections. This means that there will be no reports to Council in August 2021. Additionally, after the September 2021 election there will be a transition period for the new Council to be inducted and assigned their committees and duties. Therefore, the earliest that a report can be presented to Council will be October 2021.
