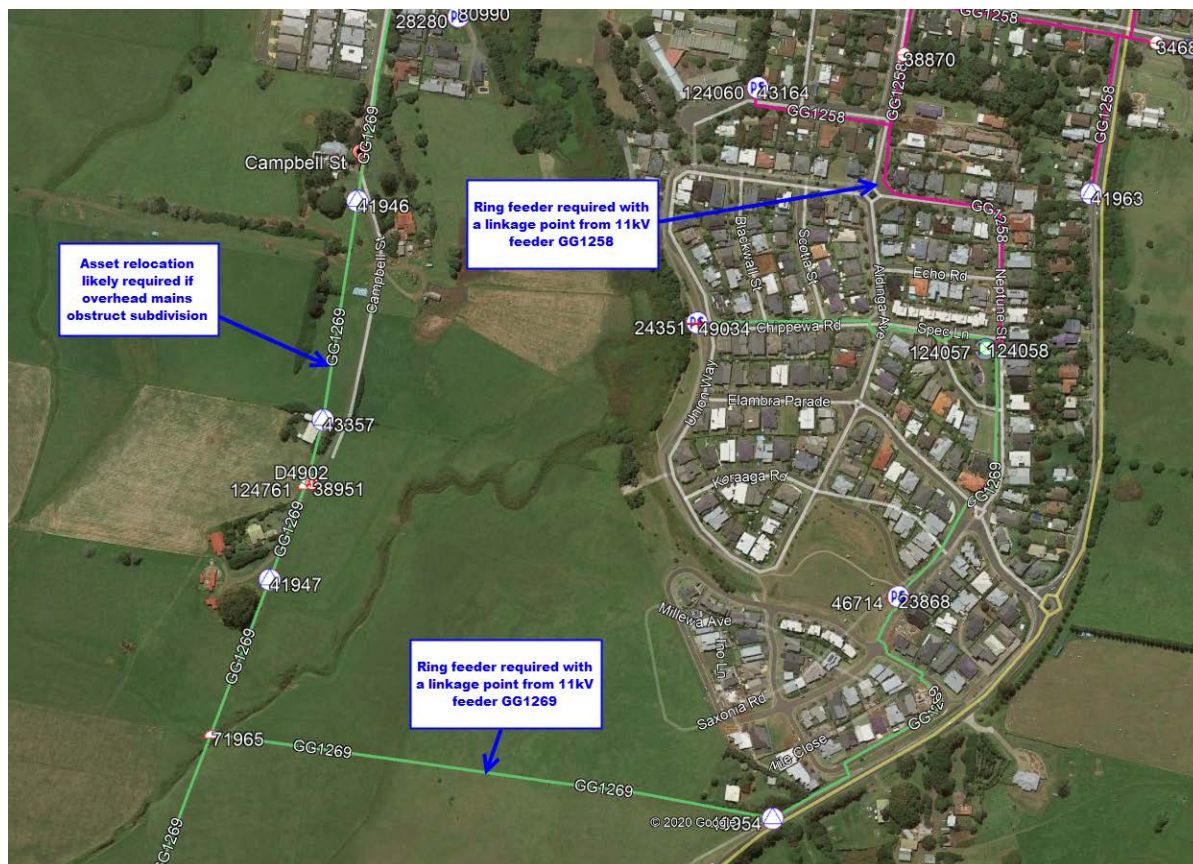
Hi James,

Thankyou for your technical enquiry submission. Your question asks to review the serving feasibility/supply needs for proposed 317 lot subdivision at Lot 2 DP 1168922 & Lot 11 DP 1045242, 48 & 86 Campbell Pde, Gerringong.

The proposed subdivision has been estimated with an after diversity maximum demand of 2MVA. After discussions with our planning group, there is available capacity on the existing network to supply this development. Two separate 11kV feeders will be required to perform a ring connection into the subdivision. Both 11kV feeders GG1258 and GG1269 are shown below.

The subdivision would be reticulated with underground network including padmount substations and 11kV cables.

I hope this is sufficient information to help you lodge an application.
