Thanks for the chat today.

As discussed, the proponent for this Planning Proposal has queried the need to carry out a BAM Assessment as part of the Gateway Determination. Council are of the opinion that a BAM Assessment is not necessary at this stage and that a 'Test of Significance' (CI7.3 of the Biodiversity Conservation Act 2016) should be carried out at this stage. If it is determined that the proposal is likely to significantly affect threatened species a BAM Assessment would then be required.
