Gateway Determination Alteration and Extension for Kiama Planning Proposal PP_KIAMA_2013_002_00 Jamberoo Road, Kiama

I refer to Planning Proposal (PP_2013_KIAMA_002_00) which rezones land along Jamberoo Road, Kiama from RU2 Rural Landscapes and E2 Environmental Conservation to R2 Low Density Residential in the Kiama Local Environmental Plan 2011.

I am aware that the above proposal has been exhibited and adopted by Council and Council has been awaiting final cadastral details for the lots subject to the planning proposal prior to finalising the draft local environmental plan. I understand these details have been confirmed and Council has requested Parliamentary Counsel to draft an amendment.

The Gateway determination, issued on 20 December 2013 identified the site of the planning proposal as Lots 1,2,3 &4 Sec 67 DP758563 and Lots 1&2 DP797732 and provided for a 12 month timeframe for completion of the local environmental plan, expiring on 20 December 2014.

I have determined, as the delegate of the Minister, in accordance with section 56(7) of the *Environmental Planning and Assessment Act, 1979*, to amend the Gateway determination to:

- update the reference of Lots 1,2,3 &4 Sec 67 DP758563 and Lots 1&2 DP797732 to Lots 201 & 202 DP1199549 and add the property identifier of Lot 1 DP1203690 to the closed length of Noorinan Street within the planning proposal site; and
- extend the time to complete the proposal by 3 months to 20 March 2015.

Alteration of Gateway Determination

Planning Proposal (Department Ref: PP_2013_KIAMA_002_00): to rezone land along Jamberoo Road Kiama to R2 Low Density Residential to allow for residential development.

I, the General Manager, Southern Region, as delegate for the Minister for Planning, have determined, under section 56(7) of the Environmental Planning and Assessment Act 1979, to alter the Gateway determination dated 20 December 2013 for the proposed amendment to the Kiama Local Environmental Plan 2011 as follows:

And replace with

"6. The timeframe for completing the Local Environmental Plan is to be 15 months from the week following the date of the Gateway determination."
