Dear Mr Head,

Planning proposal to amend Leichhardt Local Environmental Plan 2013

I am writing in response to your Council's letter dated 2 October 2014 requesting a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* (the Act) in respect of the planning proposal to correct a mapping error to reinstate the Parramatta Road Conservation Area on Leichhardt Local Environmental Plan 2013 Heritage Map sheet 005.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan is to be finalised within 3 months of the week following the date of the Gateway determination. Council's request to draft and finalise the Local Environmental Plan should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment's regional team for administrative purposes.

The State Government is committed to reducing the time taken to complete Local Environmental Plans by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2014_LEICH_006_00): to correct a mapping error to reinstate the Parramatta Road Conservation Area on Leichhardt Local Environmental Plan 2013 Heritage Map Sheet 005.

I, the Director, Metropolitan Delivery (CBD) at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Leichhardt Local Environmental Plan 2013 to correct a mapping error to reinstate the Parramatta Road Conservation Area on Leichhardt Local Environmental Plan 2013 Heritage Map Sheet 005 should proceed subject to the following conditions:

- 1. Council is to ensure that all landowners within the proposed conservation area are consulted directly on the planning proposal, which must be made available for a minimum of 14 days.
- 2. Other than as specified by Condition 1, no community consultation is required under sections 56(2)(c) and 57 of the Act.
- 3. No consultation is required with public authorities under section 56(2)(d) of the EP&A Act.
- 4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 5. The timeframe for completing the Local Environmental Plan is to be **3 months** from the week following the date of the Gateway determination.
