Planning Proposal PP_2013_SINGL_001_00 - Alteration of Gateway Determination

I refer to your letter of 26 October 2015 seeking either an extension in time to complete the planning proposal PP_2013_SINGL_001_00, or advice that the provisions of the planning proposal that are inconsistent with Section 117 Direction 1.3 are of minor significance.

Given the outstanding objection from a government agency, determining the inconsistency with Direction 1.3 is not considered appropriate at this time. However the delays that Council has experienced are recognised and the Department has written to the Department of Industry in the hope of resolving the matter. A copy of this correspondence is attached.

In these circumstances, I have determined as the delegate of the Minister, in accordance with section 56(7) of the Environmental Planning and Assessment Act, 1979, to alter the Gateway determination dated 11 June 2013 for PP_2013_SINGL_001_00 (as altered). The Gateway determination has been altered to extend the time to complete the proposal for an additional 12 months. The proposal is now due for completion on 18 December 2016.

Planning Proposal PP_2013_SINGL_001_00 - Alteration of Gateway Determination Lots 32 & 33 DP 634692, 349 Bridgman Road, Obanvale

I refer to a Planning Proposal for residential development near Rix's Creek Mine, coal title CL352.

The NSW Department of Industry objected to the planning proposal in November 2012, and re-confirmed its position in March 2015 due to the potential impacts of the Rix's Creek Mine Extension project, which is currently on exhibition.

Singleton Council has requested that the Department of Industry review its objection, on the basis that the supporting Environment Impact Statement provides further clarity on the potential impacts of any future residential development.

Council has become increasingly frustrated with the delays in a response from the Department of Industry and your early consideration of the matter would be appreciated.
