RE: Planning proposal PP-2021-5594 to amend Murray Local Environmental Plan 2011 – 17 Maiden Smith Drive, Moama.

Thank you for the Gateway Determination issued in respect to Planning Proposal PP-2021-5594. Please find attached the response to Item 1(a)-(f) inclusive for your consideration, as requested. The response has been provided in the form of an Addendum to be read in conjunction with the original Planning Proposal submission. We await your advice that the Planning Proposal is approved to progress to public consultation.
