Re: Request for Extension of Time to Finalise Planning Proposal to Amend Great Lakes Local Environmental Plan 2014 Coastal Risk Planning Area Maps

Council has prepared and is processing a Planning Proposal to amend the Coastal Risk Planning Area Maps in Great Lakes Local Environmental Plan 2014.

The Planning Proposal has been progressed in accordance with the Gateway Determination of the Department of Planning and Environment issued on 11 July 2014. A copy of the Determination is attached.

On 13 March 2015 the Department granted an extension of time to the Gateway Determination until 18 January 2016. A copy of the extension is also attached.

Council requests that the Department grant a second extension of time to allow for the following:

1. The elected Council has requested that no further action on the Planning Proposal be taken until such time as the Minister for the Environment has certified the Draft Great Lakes Coastal Zone Management Plan and Draft Jimmy's Beach Coastal Zone Management Plan.

The coastal zone management plans have been lodged with the Office of Environment and Heritage with requests for the plans to be certified. Council officers have been advised that this process may take at least six (6) months for each plan.

Therefore Council officers do not expect to be able to progress the Planning Proposal project until at least October 2016. Council's reporting requirements are then expected to result in additional delays which may extent the project for an additional two or three months.

2. The Minister for Planning announced the Coastal Reforms on 13 November 2015 and the implications for the existing coastal zone management plan projects and the Planning Proposal are somewhat unclear at this time.

Council officers will report on the Coastal Reforms to the first available Council meetings in February or March 2016. This report is expected to contain a draft submission on the Coastal Reforms and recommendations on how to progress the Planning Proposal within the new framework.

Therefore, Council requests an extension to the Gateway Determination for the Planning Proposal to amend Coastal Risk Planning Area maps in Great Lakes Local Environmental Plan 2014 until December 2016.

An amended Project Timeline is provided with this request. The request and timeline assume that the Planning Proposal will continue through to completion within the Coastal Reform framework currently on exhibition.

Upon confirmation of the extension, the Project Timeline will be incorporated into the Planning Proposal in accordance with the Gateway Determination.
