Thank you for the opportunity to comment on the planning proposal for 229 Macquarie Grove Road, Cobbity under *Camden Local Environmental Plan 2010*.

We have reviewed the planning proposal and make the following comments:

Based on the information provided, we have reviewed the planning proposal against our records and believe that there are no identified impacts on any items listed on the State Heritage Register. In relation to historic archaeology, if the proponent has not already undertaken their own investigation to assess the likelihood of 'relics' and any subsequent management required under the *Heritage Act 1977*, they should do so.

However, it is noted that the proposal has the potential to impact on one item of local heritage significance being 'Wivenhoe' (Item no. 199). This item is listed under your LEP, therefore, Council as the consent authority is responsible for the heritage assessment and consideration of any impacts to this item.

General Comments

Prior to finalisation of the proposal, Council should be satisfied that all necessary heritage assessments have been undertaken and that any impacts have been sufficiently addressed. Council's assessment should include, but not be limited to, a search of the State Heritage Inventory (<https://www.heritage.nsw.gov.au/search-for-heritage/search-for-nsw-heritage/>) and the Aboriginal Heritage Information Management System (<https://www.heritage.nsw.gov.au/protecting-our-heritage/record-aboriginal-sites/>).

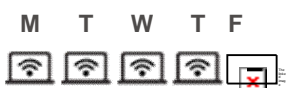
