Thanks for contacting Transport for NSW.

I refer to your below email and Council's referral to TfNSW via the NSW Planning Portal.

TfNSW Response to Planning Proposal PP-2021-6399; 10 Wonga Crescent Port Macquarie.

TfNSW has reviewed the Planning Proposal and notes that the PP does not include a technical assessment identifying the uplift in traffic and transport demand arising from the uplift in zoning from rural to residential.

Council should be satisfied that the surrounding road network has available capacity to support additional traffic and transport demands generated by the proposed uplift in zoning. Any additional peak hourly demands directed towards John Oxley Drive and the Oxley Highway will be relevant to considering the cumulative demand of other Planning Proposals, including the Port Macquarie Health and Education Precinct. Consideration should be given to the need for extension of any existing active transport facilities and/or public transport services.

Clarification of current process for PP referrals via the NSW Planning Portal

Please note that the Planning Portal accounts for the former TfNSW and RMS agencies have yet to be merged, so it is not currently possible to allocated between accounts. TfNSW is working with DPIE towards updating the portal and until this occurs referrals should be directed as if the Agencies are separate. Road and Bus transport should be referred to the RMS account and rail matters can be referred to the TfNSW account. I anticipate that Council will be advised in future if the accounts are merged, at which point the RMS option would likely not be there.
