Hi Lynda,

I am processing the Major Amendment No 1 Gateway Alteration to remove 155 Louisiana Road, Wadalba, 17W Moola Road Buff, Point and the Colongra and Halekulani Oval Rezonings.

The planning proposal 'explanation of provisions' under height of buildings Map 21 Legend has now been fixed via an erratum and has been updated on the legislation website.

I spoke with Rod Mergan about including another amendment to fix up this map. It is lot 138 DP1206605. The Lot Size Map (450m2) and the Height of Building Map (J - 9.5m) does not extend to the north east boundary as it does in all the other development standards maps and appears to be an error that was introduced during the finalisation of Wyong LEP 2013. Can you discuss with Rod and advise if you want to include this amendment in the alteration to

Major Amendment No1. It will need to be included in the explanation of provisions and will need new map tiles however I can condition this in the Alteration of Gateway Determination to update the PP for exhibition.
