# Planning proposal to amend Lake Macquarie Local Environmental Plan (LEP) 2004 and draft Lake Macquarie LEP 2013

I am writing in response to your Council's letter dated 16 August 2013 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to rezone certain land at Dora Street, Doyalson Street, Yambo Street, Wharf Street and Newcastle Street, Morisset to 3(1) Urban Centre (Core), 3(2) Urban Centre (Support) and 2(2) Residential (Urban Living) under Lake Macquarie Local Environmental Plan (LEP) 2004, or rezone the subject land to B3 Commercial Core, B4 Mixed Use and R3 Medium Density Residential under the draft Lake Macquarie LEP 2013 and amend applicable minimum lot size and maximum building height standards for the subject land.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I have also agreed the planning proposal's inconsistencies with S117 Directions 1.1 Business and Industrial Zones and 3.1 Residential Zones are of minor significance. No further approval is required in relation to these Directions.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

Council is to ensure that land owners of adjoining properties, or properties which are affected by the proposed rezoning at Morisset are consulted with directly as part of the public exhibition of this planning proposal.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the department for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

### **Gateway Determination**

**Planning proposal (Department Ref: PP\_2013\_LAKEM\_012\_00)**: to rezone land at Morisset for commercial and residential purposes and amend applicable development standards.

I, the Executive Director, Rural and Regional Planning at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Lake Macquarie Local Environmental Plan (LEP) 2004 to rezone certain land at Dora Street, Doyalson Street, Yambo Street, Wharf Street and Newcastle Street, Morisset to 3(1) Urban Centre (Core), 3(2) Urban Centre (Support) and 2(2) Residential (Urban Living) or rezone the subject land to B3 Commercial Core, B4 Mixed Use and R3 Medium Density Residential under the draft Lake Macquarie LEP 2013 and amend applicable minimum lot size and maximum building height standards for the subject land should proceed subject to the following conditions:

- 1. Prior to undertaking public exhibition, Council is to update the planning proposal to include all lot and DP numbers which are subject to this planning proposal.
- 2. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
  - (a) the planning proposal must be made publicly available for a minimum of 28 days; and
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013).
- 3. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act and/or to comply with the requirements of relevant S117 Directions:
  - Transport for NSW Roads and Maritime Services
  - NSW Education and Communities
  - Mine Subsidence Board (S117 Direction 4.2 Mine Subsidence and Unstable Land)

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.



- 4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 5. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
