EXECUTIVE SUMMARY

In accordance with Section 55 of the Environmental Planning and Assessment Act 1979, a draft Local Environmental Plan (LEP) has been prepared, known as the Housekeeping LEP, to rectify minor mapping, property description and zoning anomalies identified in the Maitland LEP 2011. These anomalies have been noted by planning staff in the time since the previous Housekeeping LEP was presented to Council over 18 months ago. The purpose of this report is to propose that the draft LEP be submitted to the Department of Planning & Environment requesting a Gateway Determination, which will permit the planning proposal to be exhibited.
