## Dear Christophe

Yes - a little later than hoped I am providing feedback on the revised massing study you forwarded to Council for review.

I acknowledge that the revision is closer to a scheme consistent with the CBD Strategy, however there remain some outstanding issues.

These issues relate to the setbacks you have put forward in the revised scheme which as you appreciate under the Strategy are linked to the achievable height for the proposal. Specifically they relate to Key Element 28 in the Strategy where, with a setback of 3 m as shown, a maximum building height of 60m would be the compliant result.

If that is acceptable to your client then the proposal would align with the Strategy and could be supported .

However if a height of 90m is sought then a 4.5m setback would be required.

As made clear under Key Element 20:

Achievement of nominated height maximums will depend on addressing site constraints, surrounding context and

other aspects of this Strategy

Setbacks on the Pacific Highway elevation are also important and should be consistent with the Strategy for this elevation.

I would encourage you to further consider massing on this site having regard to this email, and forward further revisions to Council in order to progress this Proposal to a Council meeting.

As previously outlined in my email below, our client is committed to working with Council to achieve a scheme that can be supported going forward for 845 Pacific Highway, Chatswood. Accordingly please see attached a revised massing study prepared for the site by PTW.

In response to Council's requirements outlined in its letter of 14 December 2020 for slender towers and greater setbacks above the podium, a 3m setback to the tower has now been provided on all sides in addition to the 4m ground level setback from the Pacific Highway. The approach

acknowledges Council's comment in the letter that 'strict adherence to the (CBD) Strategy setback controls may not be achievable' and in our view balances increased setbacks above the podium with a feasible floorplate size for the commercial office tower. The proposed envelope also maintains sufficient flexibility within its volume for a detailed building design to achieve design excellence through the competitive design process.

In response to the other matters raised in Council's letter, we wish to advise that the proponent accepts Council's requirements for a design excellence competition based on the requirements recently gazetted clause 6.23 of the WLEP. As promised I am responding to the revised details in relation to this current planning proposal submitted last month.

The comments relate to the Massing Study dated February 2021 dealing with built form, the slender tower objective, setbacks and street wall heights.

The other issues identified in the Council letter of 14 December 2020 remain to be addressed (design excellence, car parking rates, revised DCP provisions etc.).

As noted in that Council letter, "It is Council's view that the subject site has constraints and strict adherence to Strategy controls may not be achievable however it is considered that the Planning Proposal submitted is seeking more than this site can accommodate." The changes made have been noted, however, our above overall position has not changed.

The Council letter states "a slender tower with greater setbacks above podium and lower street wall heights to the Pacific Highway, Railway Street, Day Street and the public park is requested." Council continues to seek a revised scheme in this regard. While noting some increase in setbacks are shown on the Pacific Highway more is still required in addition to setbacks to Railway St, Day St and the public park.

The Council letter stated, "It is understood that this will result in substantial reductions to floor plate size" and this remains the case. Those further setbacks will inevitably result in a smaller floorplate, but in our view a better resolution of bulk and scale on the site.

We would strenuously suggest these issues be fully addressed and a revised massing study presented for Council's consideration, together with a response to the additional issues in Council's December latter prior to any formal resubmission, as Council looks forward to a scheme that can be supported going forward on this site.

I trust you are well. As per Craig's email below and the letter received dated 14 December, PTW have been working on revisions to the proposed building envelope to address Council's concerns in relation to the Planning Proposal for 845 Pacific Highway. More specifically, the design team has been working on an approach which achieves more slender tower form with lower street wall heights and setbacks above podium.

We attach for your feedback, a revised scheme for your consideration (without prejudice). We feel this scheme represents a positive response to Council's concerns whilst also demonstrating greater consistency with the intent of the CBD Strategy for slender towers whilst also maintaining a sufficient floor plate size for an A Grade commercial office building.

Key features of the revised scheme include the introduction of a podium, recesses at the lower levels of the tower (generally setback 6m from street wall) and chamfered tower corners which are setback between 9.7m (northern corner) and 13.8m (southern corner). The proposed chamfer results in a reduction to the building width to 46.1m and a 12.3% reduction to the floorplate GFA. This approach reduces the overall bulk of the building particularly when viewed from the Pacific Highway. In our opinion the revised scheme offers significant scope for further refinement and articulation through Council's competitive design excellence process.

We would greatly appreciate Council's expedient feedback on the revised scheme before we proceed to update the Planning Proposal documentation to re-submit to Council. We would be more than happy to meet over Teams to discuss the revised scheme and any specific comments of Council.
