Alteration of Gateway Determination

Planning proposal (Department Ref: PP_2015_WYONG_009_00)

I, the Director, Central Coast and Hunter at the Department of Planning, Industry and Environment, as delegate of the Minister for Planning and Public Spaces, have determined under section 3.34(7) of the *Environmental Planning and Assessment Act* 1979 to alter the Gateway determination dated 30 September 2015 (since altered) for the proposed amendment to the Wyong Local Environmental Plan 2013 as follows:

1. Change the name of the planning proposal:

from "to rezone land to enable commercial and residential development at 44W, 50W and 60 Parraweena Road, Gwandalan."

to "to rezone land to enable commercial and residential development at 50W and 60 Parraweena Road, Gwandalan."

2. Change the description of the planning proposal:

<u>from</u> "an amendment to the Wyong Local Environmental Plan (LEP) 2013 to rezone land to enable commercial and residential development at 44W, 50W and 60 Parraweena Road, Gwandalan"

<u>to</u> "an amendment to the Wyong Local Environmental Plan (LEP) 2013 or the draft Central Coast LEP to rezone land to enable commercial and residential development at 50W and 60 Parraweena Road, Gwandalan".

3. Delete: "condition 11"

and replace with:

a new condition 11 "The timeframe for completing the LEP is by 30 June 2020."

4. Insert: new condition 12:

"The planning proposal authority is authorised as the local plan-making authority to exercise the functions under section 3.36(2) of the Act subject to the following:

- (a) the planning proposal authority has satisfied all the conditions of the Gateway determination;
- (b) the planning proposal is consistent with section 9.1 Directions or the Secretary has agreed that any inconsistencies are justified; and
- (c) there are no outstanding written objections from public authorities."
