## REQUEST NOT TO PROCEED WITH THE PLANNING PROPOSAL PP 2010 SINGL 008 00 - WATTLE PONDS, SINGLETON

## PURPOSE

To recommend the Minister's delegate alter the Gateway Determination in accordance with the s56(7) of the Environmental Planning & Assessment Act, 1979, to enable the Planning Proposal PP\_2010\_SINGL\_008\_00 to not proceed.

### RECOMMENDATION

It is RECOMMENDED that the Minister's delegate:

- **alter** the original Gateway Determination under s56(7) of the Act to enable the Planning Proposal to not proceed.
- signs the letter to Singleton Council (Tag A).

### **CURRENT POSITION**

- Singleton Council wrote to the Department of Planning and Infrastructure on 23 April 2012 advising that it did not intend to proceed with the Planning Proposal (**Tag B**).
- Briefing Note qA 140733 (**Tag C**), signed by the Director General on 8 June 2012, had the intention of altering the Gateway so the Planning Proposal may not proceed. However, this did not have desired effect as it called up section 58(4) rather than section 56(7) of the Act.
- This error was identified through internal review of the Gateway processes, and Council has been verbally advised.
- The Region supports the request to not proceed with the Planning Proposal as a second Planning Proposal (PP\_2012\_SINGL\_002\_00) has been commenced which proposes a more appropriate zoning (E4 Environmental Living) for the environmentally sensitive site.
