At its meeting of 26 November 2014, Council resolved to prepare a Planning Proposal to amend Wyong Local Environmental Plan (LEP) 2013, in relation to the following parcels of land:

- Lot 642 DP 1027231 (405-415 Pacific Highway, Lake Munmorah)
- Lot 644 DP 1027231 (2 Kanangra Drive, Crangan Bay)
- Lot 100 DP 1044282 (425 Pacific Highway, Crangan Bay)
