## PLANNING PROPOSAL - GLENNIFER BRAE - EXTENSION

#### **PURPOSE**

 To recommend the Minister's delegate alter the Gateway Determination for PP\_2012\_WOLLG\_001\_00 – Glennifer Brae, Lot 3 DP 252695 Corner of Murphys Avenue and Robsons Road, Keiraville, to allow additional time to complete the LEP.

#### RECOMMENDATION

It is RECOMMENDED that the Minister's delegate:

- agree pursuant to s56(7) of the Environmental Planning and Assessment Act, 1979, to amend the Gateway Determination to allow an additional 12 months to complete the LEP;
- sign the amending Gateway Determination (Tag A); and
- sign the letter to Council (Tag B).

#### **CURRENT POSITION**

- Wollongong Council has prepared a Planning Proposal to reclassify the Glennifer Brae
  Manor House land to facilitate the leasing of the Manor and grounds to the University of
  Wollongong; and to rezone and reclassify the Wollongong Conservatorium of Music lands
  to enable the site to be sold to the University and redeveloped as a Creative Arts Centre.
- The Gateway Determination required the LEP to be finalised by 24 February 2013.
- The Planning Proposal generated significant community discussion, with vocal support for, and against to the Planning Proposal.
- On 10 December 2012, Council resolved to not proceed with the Planning Proposal at this time; and to undertake additional community consultation and negotiations with the University of Wollongong.
- On 29 January 2013, Council rescinded this decision, however, Council remains committed to undertaking additional consultation and investigations into options for the Manor House and surrounding lands.

 Council has requested an additional 12 months to undertake the additional consultation and investigations.
