## REFERRAL TO THE LEP GATEWAY REVIEW PANEL PLANNING PROPOSAL Lots 4 & 5 DP 243425 and Lot 22 DP 255386 Tallwood Drive and Old Soldiers Road, Rainbow Flat

Greater Taree City Council (GTCC) has received a Planning Proposal for land in Tallwood Drive and Old Soldiers Road at rainbow Flat. Blueprint Planning has been engaged by GTCC to assess and process the Planning Proposal.

The Planning Proposal has been prepared by the applicant's consultant, CoastPlan Group. Council considered a report on the Planning Proposal at its meeting of 15 October 2014 and resolved:

- i. That the planning proposal for Lots 4 & 5 DP 243425 and Lot 22 DP 255386 be amended to indicate that it is seeking a minimum lot size of 1.5ha for areas to be zoned R5 Large Lot Residential,
- ii. That the amended planning proposal for Lots 4 & 5 DP 243425 and Lot 22 DP 255386 be forwarded to the Department of Planning and Environment for a Gateway determination from the Minister for Planning to support the proposal and undertake community consultation,
- iii. That, should a successful Gateway determination be provided, that the additional studies identified in this report be prepared by the applicant prior to undertaking community consultation and that the planning proposal be amended accordingly on the findings of the specialist studies, and
- iv. That community consultation be undertaken in accordance with the requirements determined by the Minister for Planning.

The applicant has submitted an amended Planning Proposal in accordance with council's resolution.

resolution. It is considered that the Planning Proposal has been prepared in accordance with the NSW Department of Planning and Infrastructure's "A Guide to Preparing Local Environmental Plansment (October 2012)".
