Re: Apollo Fabrications - Planning Proposal for Telegraph Road, Young NSW 2594

Apollo Fabrication Group Pty Ltd (Apollo) is delighted to submit our Planning Proposal (PP), a high-level planning document that addresses and considers the environmental impact and strategic merit of the future use of Land at Telegraph Road, Young for an expansion of our steel fabrication facility to Hilltops Council (HC).

Our PP intends to amend planning provisions relating to land holdings, currently owned and controlled by Apollo Fabrications, that will enable the use of the land for industrial purposes, specifically steel fabrication. Our PP will also help inform the draft Hilltops Local Environmental Plan that has received Gateway approval from NSW Department of Planning Industry & Environment (DPIE) and which has been on public exhibition.

By adopting best practice acoustic engineering design and construction techniques, our consultants have advised that it is possible for Apollo to expand its premises in such a way that will minimise its impacts on neighbours by containing, abating and mitigating the noise it generates.

Once complete, economic forecasts show that at least \$103m and 164 jobs will be added to the annual regional Hilltops economy and an additional \$5m per annum thereafter.

Apollo's PP has been prepared by Salvestro Planning and is supported by independent technical assessment and peer review (see below). In all cases, the analysis undertaken by our experts supports the expansion of our fabrication facilities by validating strategic merit and demonstrating that all (minor) environmental impacts can be effectively mitigated, contained, and/or abated.

Hilltops Council

The conclusions and recommendations generated from the Hilltops Council strategic documents including the Hilltops Council Economic Growth and Land Use Strategy (March 2019), the Hilltops Freight and Transport Study – Final Report (May 2019) and Hilltops Council Local Strategic Planning Statement (2020-2040) support the objectives of this proposal and the potential for considering further industrial use on the subject Telegraph Road, as further detailed below.

Apollo is excited by the prospect of expanding its facilities and increasing employment and skilled development opportunities for the Hilltops regional economy.

Notwithstanding this, our economic team has identified that the total economic benefit/contribution from one year of Apollo's existing operation to the HC Local Government Area (LGA) is \$15.8 million and some 72 jobs and would be lost should Apollo be left with no choice but to relocate from the LGA.
