## Re: Planning Proposal – Leppington Town Centre

Dear Adrian,

Pursuant I refer to the attached Planning Proposal lodged in the NSW Planning Portal for the Department of Planning and Environment's consideration.

Leppington Town Centre is located in the South West Growth Area identified by the NSW Government. It spans across both Camden Council and Liverpool City Council.

The Planning Proposal has been prepared by both Camden and Liverpool City Council together which is consistent with Section 3.32 (5) of the Environmental Planning and Assessment Act 1979.

At its meeting on 26 October 2022, Council resolved to submit this Planning Proposal to the Department of Planning and Environment (DPE) for Gateway Determination. On 8 November 2022, Camden Council also resolved to submit the Planning Proposal to DPE for Gateway Determination.

The Planning Proposal has been prepared in response to the ongoing review of the Leppington Town Centre which has been brought upon by:

- limited development activity since original 2013 rezoning;
- announcement of the Aerotropolis;
- planned extension of the rail line to the Aerotropolis;
- planned high frequency bus corridors; and

being identified as a Strategic Centre in the Region Plan, the District Plan and Liverpool Council's Local Strategic Planning Statement.

The Planning Proposal is an application to amend the planning controls and introduce new maps into the State Environment Planning Policy (Precincts – Western Parkland City) 2021 (Western Parkland City SEPP). The Planning Proposal is seeking to introduce
