# NOTICE OF EXHIBITION – Planning Proposal (PP-2022-4350) at 1-7 Rangers Road and 50 Yeo Street, Neutral Bay

The planning proposal that applies to 1-7 Rangers Road and 50 Yeo Street, Neutral Bay (PP-2022-4350) is on public exhibition from **Monday**, **13 May 2024 until Tuesday**, **11 June 2024**.

### About the planning proposal

The site is located at 1-7 Rangers Road and 50 Yeo Street, Neutral Bay and contains three separate parcels of land (Lots 1, 2 and 3 in DP 1091373).

The planning proposal seeks to amend the North Sydney LEP 2013 to:

- increase the maximum building height from 16m to part 26m and part 31m; and
- increase the minimum non-residential FSR from 0.5:1 to 1.8:1.

The Sydney North Planning Panel is the Planning Proposal Authority, and the Department will be the Local Plan-Making Authority.

Persons lodging submissions must declare reportable political donations (including donations of \$1000 or more) made in the previous two years.

We may publish any personal information you have included in your submissions on a proposal. Do not include any personal information in your submission that you do not want published. If you do not want your name and address to be made public, please ensure you tick the relevant box and clearly state this on the front page of your submission.
