Planning Proposal (PP068) - Heritage Listing: Former Huskisson Anglican Church and Site (comprising the land identified as Lots 7-9 Section 3 DP 758530)

Shoalhaven Local Environmental Plan (LEP) 2014

Lot 7 Section 3 DP 758530, 17 Hawke Street HUSKISSON

Lot 8 Section 3 DP 758530, 22 Currambene Street HUSKISSON

Lot 9 Section 3 DP 758530, 26 Currambene Street HUSKISSON



Background & Overview

The Planning Proposal (PP068) – Heritage Listing: Former Anglican Church and Site (comprising the land identified as Lots 7-9 Section 3 DP 758530) seeks to amend Schedule 5 Environmental Heritage (and associated mapping) of the Shoalhaven LEP 2014 to include the Former Huskisson Anglican Church and its site as a heritage item of local significance.

The PP covers three lots that are considered contributory to the heritage significance of the Former Huskisson Anglican Church, being Lots 7-9 Section 3 DP 758530 (17 Hawke Street, and 22-26 Currambene Street, Huskisson).

The PP is supported by a contemporary Statement of Heritage Significance (SoHS) and accompanying NSW State Heritage Inventory Form (HIF). These were prepared following a resolution of Council on 20 September 2022 (MIN22.618) to commence the process to immediately list the Former Huskisson Anglican Church (including Lots 7 & 8 Section 3 DP 758530) and any associated items on the site as an item of local heritage significance in the Shoalhaven LEP 2014.

The SoHS demonstrates that the Former Huskisson Anglican Church, and the broader site on which it is located, meet the threshold for heritage listing under the NSW heritage assessment criteria. A supplementary statement to the SoHS also clarifies the recommendation to include Lot 9 Section 3 DP 758530 in the heritage listing and statutory curtilage of the item, following discussions with the Jerrinja Local Aboriginal Land Council.

Proposed Changes

The Planning Proposal (PP068) seeks to include the Former Huskisson Anglican Church and Site (comprising the land identified as Lots 7-9 Section 3 DP 758530) as an item of local heritage significance in the Shoalhaven LEP 2014 by:

- Including Lots 7-9 Section 3 DP 758530 (17 Hawke Street and 22-26 Currambene Street, Huskisson) as Item 553 in Schedule 5 Environmental heritage of the Shoalhaven LEP 2014.
- Updating the corresponding Shoalhaven LEP 2014 Map Sheet (HER_020C) to apply the heritage layer over Lots 7-9 Section 3 DP 758530.

Council has been delegated the plan making functions for this planning proposal.
