# Exhibition of Planning Proposal Montefiore Seniors Living planning proposal (PP-2023-1109)

The planning proposal seeks to rezone part of the site to SP2 Infrastructure and increase both height and floor space ratio to increase the capacity of senior housing

### Site description

The site is located at 116-120 High Street, 2-20 Gaza Avenue and 45-47 Barons Crescent, Hunters Hill and comprises multiple land parcels (Lot 2 DP 312298, Lot 9-10 DP 724017, Lot 1-2 DP 325793, Lot 62-63 DP 161119, Lots 50-61 DP 16119). It is a roughly triangular island site with an approximate total area of 40,878m² and frontages Barons Crescent (north and east), High Street (south), and Gaza Avenue (west). The site is currently occupied by a one- and two- storey residential aged care facility (RACF) in the south-east corner, 10 dwelling houses (up to two-storey) that front Gaza Avenue to the west, a synagogue, and a heritage garden, all of which will be retained except the 10 dwelling houses. The existing RACF will retain its current R2 Low Density Residential zoning and existing HOB of 8.5m. The heritage garden, and low-density housing on Gaza Street and High Street will retain their existing HOB of 8.5m.

#### What the planning proposal will do

The planning proposal seeks to amend the *Hunters Hill Local Environmental Plan (LEP) 2012* to increase the number of Independent Living Units (ILUs) from 18 to 144 and reduce the number of aged care beds from 334 to 194 on site.

In summary, it seeks to:

- rezone part of the site from R2 Low Density Residential to SP2 Infrastructure (Seniors Housing)
- increase the maximum height of building (HOB) for part of the site from 8.5m to varying heights of 16m, 18m, and 24m
- increase the floor space ratio (FSR) for part of the site from 0.5:1 to 1:1

The existing RACF will retain its current *R2 Low Density Residential* zoning and existing HOB of 8.5m. The heritage garden, and low-density housing on Gaza Street and High Street will retain their existing HOB of 8.5m.
