# TIA Yellow Pinch Dam Water Treatment Plant – LOT: 882 DP: 789858 – 43 Red Gum Road, YELLOW PINCH

### Context

TfNSW notes for this PP:

- The key state road is the Princes Highway
- Council is seeking advice from TfNSW to assist in its assessment of the TIA which is supporting document for the associated PP.
- The PP seeks to amend Bega Valley Local Environmental Plan 2013 to enable a Water Treatment Plant to be constructed and operate at the subject site by amending a section of the site's zoning from C3 Environmental Management to SP2 Infrastructure – Water Supply.

#### Comments

- Should this PP proceed, TfNSW believes any future development application needs to be supported with a Construction Traffic Management Plan (CTMP). This Plan would need to include, but not be limited to, a Drivers Code of Conduct which would detail the scheduling of construction vehicles, deliveries, concrete trucks etc outside of school bus operating time.
- TfNSW notes a speed reduction is proposed on the Princes Highway. The CTMP accompanying any future development application. Any speed reduction would need to be justifiable and intuitive to motorists on the Princes Highway. Any proposed reduction of the speed limit on the Princes Highway would require the proponent to apply for and obtain a Road Occupancy Licence (ROL) as well as receive Speed Zone Authorisation from the TfNSW Traffic Operations Unit (TOU).
