### PLANNING PROPOSAL

PP-2023-1567 – Shoalhaven LGA – 29 Sheraton Circuit, Bomaderry (as described in Schedule 1).

### PANEL CONSIDERATION AND DECISION

The Panel considered: the material listed at item 4, and the material presented at the briefing listed at item 5 in Schedule 1.

As the Planning Proposal Authority, the Panel determined to recommend to the Minister that the proposed instrument, as described in Schedule 1, should be made.

The Panel's decision was unanimous.

#### **REASONS FOR THE DECISION**

The Panel considered the Department of Planning, Housing and Infrastructure's Post-Exhibition Report, 17 July 2024 and met with the Department.

The Panel concurred with the Department's Post Exhibition Report that the planning proposal demonstrated strategic and site-specific merit, the conditions of the Gateway had been met, agency and community consultation had occurred in accordance with the Gateway Determination requirements and submissions raised had been adequately addressed by the Department and Jervis Bay Town Planning. Consequently, the proposal warranted support.

## CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the Panel noted that no community submissions were received and a submission was received from Shoalhaven City Council, Transport for NSW and the Rural Fire Service. The Panel notes that issues raised by these parties included future intensive site development, traffic issues & setting precedence. The Panel considers that the concerns raised have been adequately addressed in the Department's Post-Exhibition Report and this Record of Decision.
