Physical Description

This is a substantial weatherboard house with a steeply pitched hipped roof and projecting gables to the front, and to the side. Bullnose profile roof to wrap around verandah. Two prominent chimneys punctuate the roofline with terracotta chimney pots over moulded corbelling. Cement rendered steps and posts lead to the entry door fielded panel door which has transom light. The front gable features a bay window with corbelled eaves, fluted detailing to the walls, margin glazed double hung sash window to the centre and single double hung to the sides. A pair of narrow double hung windows are centred on the front wall.

The weatherboards are cut to resemble stonework on the front elevation and may have been painted in shading to emulate stonework when first constructed which could be revealed in paint scrapes.Cast iron lacework if featured on the verandah between chamfered posts with capital mouldings and cast-iron curved brackets.

A decorative picket fence enhances the setting of the house to the streetscape and defines the private space. Small palms, a frangipani tree and shrubs are located in the front garden. Internally the house retains an original layout to principal rooms and has been extended at the rear in a sympathetic manner. it retains a large leafy garden. The house is quite intact to original details.

Historical Notes or Provenance

INDIGENOUS HISTORY

Grafton lies within the lands of the Bundjalung Aboriginal people whose territory stretches across the far nort east coast of NSW from the northern side of the Clarence River in Grafton. Clarence Valley Aboriginal Heritage Study 2015 by Australian Museum Services provides an overview of Aboriginal Heritage of the Clarence Valley and notes publicly listed sites of significance in, or adjoining the Grafton Heritage Conservation Area which include the Clarence River, Susan and Elizabeth Islands and Fisher Park Lagoon near the Showground. Clarence Valley Council adopted a policy in 2018 on Cultural Heritage which states:

Aboriginal places and objects are an important part of the rich heritage of the Clarence Valley local government area (LGA), providing links to culture, environment and knowledge for local Aboriginal communities.Council acknowledges the Bundjalung, Gumbaynggirr and Yaegl peoples as the traditional owners and custodians of the lands and waters that lie within the Clarence Valley Council boundaries.Council in its role as a planning and consent authority and as a land manager is committed to working with Aboriginal custodians and native title holders within the LGA to protect places of culturalsignificance.

NON INDIGENOUS

The Thematic History of Grafton dated 2004 by Brett Stubbs provides an overview of the historical themes which have shaped the development of the city. There are many other publications available which provide historical information. A brief summary is provided below to provide a historical context.

The credit for discovering the Clarence River is often given to a convict named Richard Craig who, after escaping from Moreton Bay, spent a year making his way south towards Port Macquarie where he arrived in 1831. It is probable that he made good use of his knowledge in his employ with Sydney timber millers Thomas and John Small, and it seems likely that it was at Craig's suggestion that the brothers sent the Susan to the 'Big River' in 1838. No official interest, however, seems to have been taken in the region until after Butcher's report late in 1838. (Stubbs)

Like many river towns, the first settlers to arrive during the 1830s-40s were cedar getters and a small settlement grew on the southern side of the river which soon developed to the northern side. In 1948 Government Surveyor William Darke laid out the town plan and land sales commenced in 1850. In 1851 Governor Fitzroy officially named the town 'Grafton', after his grandfather, the Duke of Grafton, who had served as Prime Minister of the United Kingdom from 1768 to 1770. In 1958 Grafton was one of the first towns to petition to become a municipality which was granted on 20 July 1859. by this time there were many civic buildings in place, a gaol, ferry, hospital, and churches.

Grafton is significant as the first city on the North Coast. It was proclaimed as a city, and South Grafton as a town, in 1885, under the Crown Lands Act 1884, (NSW Government Gazette 20 March 1885 Page 1853). At this time there were only 6 cities in NSW: Sydney, Newcastle, Bathurst, Armidale Goulburn and Grafton. Hence this was an important centre in the northern region which is reflected in the quality of public buildings and the strong legacy of

its heritage building stock.

in 1879 Grafton seed merchant and nurseryman Henry Volkers was engaged for the planting of the city streetscapes with the Jacaranda tree; Jacaranda mimosifolia and during the 1880s he suppled hundreds of trees. By the 1920s, as the avenues became established, this attracted regular visitors, and in 1934, led to the formation of a Floral Festival. The Jacaranda Festival continues to this day and is an event of great social significance to the local community and attracts visitors from around the world to see the stunning purple blossom lined streets.

1932, the same year as the opening of the Sydney Harbour Bridge, saw the construction of the Grafton Rail and Road bridge which shaped another phase of development of the city and impacted on the development of South Grafton.

The garden suburb of Dovedale developed as an interwar era suburb along the eastern river front, and takes its name from the property Dovedale of about 60 acres and the residence of W. A. B. Greaves, the district surveyor. Mr Greaves was born at Mayfield in Staffordshire, England, and named his property after the famous beauty spot called Dovedale, in the Peak District now under ownership of the National Trust.

During the 1950s, there was substantial industrial growth with the development of the Match Factory Great Marlow, Peters ice Cream Factory in Westlawn, , and the Tooheys Brewery, in North Street, all of which closed in later years due to centralisation of economic production. The latter two remain as heritage listed industrial sites and some ongoing uses.

THIS ITEM

The early history of this quality Federation style historic residence is not known. The historic maps show the original land owner was John McFadden, who was a pioneer of Grafton and potentially had a part in the construction of the house. The dwelling is located in a historic precinct of Victoria Street close to Roches hotel and containing a high proportion of heritage items. The house demonstrates the confidence in the deveopment of Grafton around the turn of the 20th century.
