| Purpose of the Report: | To provide Council with the feedback from the community engagement regarding the St George Greek Orthodox Church. To obtains Councils approval to proceed with a planning proposal to list the St George Church, Rose Bay as a local heritage item in Schedule 5 and on the heritage maps of the Woollahra Local Environmental Plan 2014. | |

Recommendation:

- A. THAT Council endorse the preparation of a planning proposal to list the *St George Greek Orthodox Church and war memorial complex and setting, including interiors and moveable heritage at 90-92 Newcastle Street, Rose Bay (Lots 15 & 16, Sec D, DP5092)* as a local heritage item in Schedule 5 and on the Heritage Map of the *Woollahra Local Environmental Plan 2014* and resolve to forward this to the Department of Planning and Environment with a request for a Gateway determination to allow public exhibition.
- B. THAT Council request the Minister for Planning and Public Spaces (or delegate) authorise Council as the local plan-making authority in relation to the planning proposal, to make the local environmental plan under section 3.36 of the *Environmental Planning and Assessment Act 1979*.

Executive Summary:

This report has been prepared in response to resolution of Council from 27 March 2023 that engagement be undertaken seeking community feedback regarding the proposed local heritage listing of the St George Greek Orthodox Church in Rose Bay.

Community Engagement commenced on 24 May 2023 and formally closed on 9 June 2023. However, late submissions continued to be received and are considered within this report. Having considered the issues raised in submissions, and the confidential legal advice, Council staff maintain their recommendation that Council resolves to proceed with a planning proposal to list the St George War Memorial Church at 90-92 Newcastle Street Rose Bay (Lot 15 & 16, Sec D, DP 5092) as a local heritage item in Schedule 5 and on the heritage maps of the Woollahra Local Environmental Plan 2014 (Woollahra LEP 2014).

Discussion:

Background

On 6 March 2023 the Environmental Planning Committee (EPC) considered a report on the outcomes of the Places of Public Worship Heritage Study, and the advice of the Woollahra Local Planning Panel (see **Attachment 1**). Subsequently, on 27 March 2023 Council resolved:

- A. THAT Council note the advice provided by the Woollahra Local Planning Panel on 13 December 2022 regarding the planning proposal to list five places of worship as local heritage items in Schedule 5 and on the Heritage Map of the Woollahra Local Environmental Plan 2014.
- B. THAT Council endorse the planning proposal as contained at Attachment 3 of the report to the Environmental Planning Committee to list the following five sites as local heritage items in Schedule 5 and on the Heritage Map of the Woollahra Local Environmental Plan 2014 and resolve to forward this to the Department of Planning and Environment with a request for a Gateway determination to allow public exhibition:
 - *i.* Paddington Church of Christ complex and setting, including interiors and moveable heritage at 116-122 Paddington Street, Paddington (Lots 20, 21 & 22, Sec 1, DP 180)
 - *ii.* St Andrews Scots Presbyterian Church complex and setting, including interiors and moveable heritage at 2 Carlisle Street, Rose Bay (Lot 1 DP 724928 & Lot 1 DP 966535)
 - *iv.* Sydney Chevra Kadisha, including interiors and moveable heritage at 172-178 Oxford Street, Woollahra (Lot 1 DP 85862)
 - v. Vaucluse Uniting Church complex and setting former 1909 Vaucluse Congregational Church building and former 1960 A-frame church building, including interiors and moveable heritage at 3 Russell Street, Vaucluse (Lot 6, Sec 5, DP 4400).
- C. THAT Council request the Minister for Planning and Public Spaces (or delegate) authorise Council as the local plan-making authority in relation to the planning proposal, to make the local environmental plan under section 3.36 of the Environmental Planning and Assessment Act 1979.
- D. THAT Council endorse a nomination to the State Heritage Register of Sydney Chevra Kadisha, including interiors and moveable heritage at 172-178 Oxford Street, Woollahra (Lot 1 DP 85862).
- E. THAT Council receives and notes the recommendation for the St George Greek Orthodox Church, and staff further investigate the heritage significance of the complex having regard to the issues raised regarding religious freedoms, and that the community are engaged to establish if there are elements of the building that are appropriate for heritage listing, investigates whether there is an active Development Application (DA) for the site on the corner of Old South Head Road and Newcastle Street, Rose Bay and/or if further legal advice is required.
- F. THAT Council request that staff update the heritage inventory sheet for this Sydney Chevra Kadisha, having considered the late correspondence from URBIS that was tabled at the Environmental Planning Committee meeting of 6 March 2023.

In response to Parts A, B, C & F of the Council resolution, on 20 April 2023 Council staff lodged an updated planning proposal with the Department of Planning and Environment (DPE) requesting a Gateway determination to allow public exhibition to list four places of public worship as local heritage items. We anticipate that the planning proposal will be placed on public exhibition in the coming months.

In response to Part D, Council staff will progress a nomination to the State Heritage Register for the Sydney Chevra Kadisha, including interiors and moveable heritage.

Community Engagement

In response to Part E of the Council resolution, Council staff developed and implemented a community engagement strategy aimed at collecting information and feedback from the community regarding their thoughts on the significance of the Church. The formal community engagement occurred from Wednesday 24 May 2023 to Friday 9 June 2023 (inclusive). A small number of submissions were received after 9 June, and these have been considered as part of this report.

The exhibition included the following:

- 1. Notices in the Wentworth Courier newspaper, appearing on 24 and 31 May 2023.
- 2. The preparation of a fact sheet providing general information on the issues, with a QR code linking to further information online through Council's dedicated YourSay Woollahra webpage (see **Attachment 2**).

- 6. The printed fact sheet was sent to approximately 400 owners of properties in the immediate vicinity of the Church. This included residences in both the Woollahra and Waverley LGA.

Submissions

In response to the notification, we received the following:

- Seven individual submissions received via Council's YourSay page.
- Ten individual submissions received via email.

¹ This dedicated webpage included copies of all relevant committee reports, minutes, previous submissions and late correspondence (including objections) that related to this matter.

Of the 17 individual submissions, 12 submissions (70%) were in support of heritage listing of the St George Church. There were two submissions demonstrating significant additional research that has been undertaken to help inform their submission. A copy of the redacted submissions are attached at **Attachment 3**.

In addition to the individual submissions received, a group submission (or petition) was submitted by the Greek Orthodox Parish of St George Rose Bay. The submission included a covering letter outlining the overall sentiment of the group which is opposed to the proposed heritage listing, and contained 984 signatories and 218 comments. A copy of this correspondence is at **Attachment 4**.

The general issues raised in the objection to the heritage listing, and a response from staff is provided in the table below.

| Issues | Staff response |

| The building has no heritage value and does not fit the criteria for local significance. The architecture of the Church is not significant. The building is not old enough to be heritage listed. Despite modifications and upgrades, the Church building still maintains the above qualities and 'intangible' values. The purpose of heritage listing is not only to protect places that are old, but to also preserve places that reveal and tell the story of our past, for future generations to appreciate. |
| Heritage listing is an impediment to future development of the Church. Heritage listing will hinder future growth of the congregation by limiting the building's functions. | There is no policy or control in Council's LEP or DCP that denies development for heritage places. Heritage listing will protect the significant values of a place as it grows into the future, and any DA would be considered and assessed on its merits. The LEP controls for heritage aim to manage changes to a building so that they appropriately conserve the significance of a place. This may mean that alterations, upgrades, and new developments like additions and extensions are guided and considered in their design to be more sensitive to the heritage building. |
| The Church community should be in charge of how it manages the building and how it is used to support its functions. Heritage listing will mean Council will take control of what Church needs to provide for the congregation. The Church will not be free to adapt. | The owners of heritage listed places are still in charge of managing their properties within the necessary planning frameworks. Heritage listing does not mean Council will take over management of the place. Rather, future proposals to adapt the place will be required to consider and respond to the identified values of the place. |

| Heritage listing will result in a significant financial impact with regards to heritage compliance costs. | Heritage listing may require additional studies and management documents during the DA process which will have financial implications. In the context of helping to facilitate the ongoing management of the identified heritage values of the site, the requirement for additional documentation is not considered unreasonable. |
| Heritage listing is a revenue stream for Council. It is an intrusion of politics into religion. | Heritage listing means that a heritage place is listed in Schedule 5 of the Woollahra LEP 2014. There are no fees collected for including a place in the LEP, nor are there any ongoing fees for keeping a place heritage listed. Council does not receive addition fees for assessing DAs for heritage places. |
| St Therapon Thornleigh is heritage listed, and parts of the building are now falling into disrepair because of the dealing with government bodies. | Whilst this comment is noted, there is no evidence to suggest that there is a nexus between heritage listing and listed items falling into disrepair. There are mechanisms in the Woollahra LEP 2014 to allow for minor and maintenance works to be carried out without requiring development consent under the provisions of Clause 5.10(3) where those works would not adversely affect the heritage significance of the site. |

Based on the issues raised in the submissions, Council's position regarding the significance of the St George Greek Orthodox Church and its ability to meet six of the seven criteria for assessing heritage significance has not changed. Taking into consideration the community feedback in addition to the information and research presented in the Places of Worship Heritage Study, the St George Greek Orthodox Church meets the following significance criteria for inclusion into the Schedule 5 of the Woollahra LEP 2014:

- **Historical Significance** a Church built as a war memorial commemorating Australian soldiers of Greek Heritage.
- **Associative significance** associations with Australia's migrant communities, as well as its association with Australia's defence history.
- Aesthetic significance the Church is a fine example of the work of the prominent Inter-War architectural firm Fowell, Mansfield & Maclurcan. Joseph Charles Fowell is recognised as a prominent Australian twentieth century architect, particularly renowned for his ecclesiastical architecture. It incorporates elements of the Byzantine style typically associated with ANZAC memorials, with the traditional Greek Orthodox Church style. Within its residential setting, the Church has landmark qualities.

- **Social significance** although social significance has not been formally assessed, it is assumed the St George Greek Orthodox Church is held in high esteem by members of the Parish and the broader Greek Orthodox community of Sydney. It also has social significance as a war memorial specifically recognising members of the Greek community in Australia that served in WW1 and WW2, as well as Australians that served and died on military campaigns in Greece.
- **Rarity** is a rare example of a Greek Orthodox Church that is also a war memorial (there is only one other in Sydney St Spyridon, Randwick).
- **Representativeness** The St George Greek Orthodox Church is fine and representative of the ecclesiastical buildings designed by architectural practice Fowell Mansfield & Maclurcan.

Council staff therefore maintain the recommendation that a planning proposal to list the St George Greek Orthodox Church in Rose Bay in the Woollahra LEP 2014: Schedule 5 as a local heritage item, should proceed.

In response to Part E of the Council resolution and with regard to other elements of the building that warrants heritage listing, a number of comments from the feedback expressed that the building contained highly decorative and fine interiors including the iconoclasts. Based on this feedback, Council staff recommend that the proposed heritage listing which includes "interiors" should be maintained.

In response to Part E of the Council resolution regarding religious freedoms, Council staff obtained independent legal advice, and have no concerns proceeding with the planning proposal.

In response to Part E of the Council resolution and with regard to any active development applications (DA) on the site, Council staff have found that a DA for sites at 88, 90-92, 94 and 96 Newcastle Street was approved by the Joint Regional Planning Panel in December 2011. The development involves the consolidation of all sites, the retention of the Greek Orthodox Church at 90-92 Newcastle Street, the demolition of dwelling houses and the former St Pauls Anglican Church, and the demolition of the ancillary buildings, and construction of a childcare centre and residential flat building.

At present, there is no evidence in Council's system to indicate that these works have commenced, with the buildings at 88, 94 and 96 Newcastle Street still extant. However, we note that the approved DA seeks to retain the St George Greek Orthodox Church building, an outcome that does not contradict the intentions of the proposed local heritage listing.

Options:

Noting the issues raised in submissions, and based on the Places of Public Worship Heritage Study, staff recommend progressing a planning proposal to list the St George Greek Orthodox Church and war memorial complex and setting, including interiors and moveable heritage at 90-92 Newcastle Street, Rose Bay (Lots 15 & 16, Sec D, DP5092) as a local heritage item in Schedule 5 and on the Heritage Map of the Woollahra LEP 2014.

To streamline the plan-making process, the Minister can delegate some plan-making powers to Council for routine matters. In this case, Council may request delegation to exercise the functions of the Minister to make an LEP under section 3.36 of the Act. Part B of the recommendation for this report deals with this request. After public exhibition, the planning proposal and submissions received will be reported to Council.

Alternatively, Council may decide not to progress with a planning proposal to heritage list the St George Greek Orthodox Church.

Community Engagement and / or Internal Consultation:

Refer to the Discussion section of this report, under sub-heading "Community Engagement".

Policy Implications:

Should Council resolve to progress with a planning proposal there will be policy implications by amending the Woollahra LEP 2014.

Financial Implications:

Should Council resolve to progress with a planning proposal, there will be financial implications to implement the advertising and community engagement process.

Resourcing Implications:

Should Council resolve to progress with a planning proposal to finalisation, staff resources will be associated with the public exhibition process, liaising with the DPE and Parliamentary Counsel.

Conclusion:

In response to a Council resolution from 27 March 2023, Council staff have engaged with the local community to obtain their feedback on the heritage significance of the St George Greek Orthodox Church.

Having considered the matters raised in the submissions, staff recommend that Council resolves to proceed with a planning proposal to list the St George Greek Orthodox Church and war memorial complex and setting, including interiors and moveable heritage as a local heritage item.

RE: Support for heritage listing of St George Greek Orthodox Memorial Church, 90-92 Newcastle Street, Rose Bay (the site) complex and its setting.



The planning proposal for the heritage listing of St George was considered by the Council's Environmental Planning Committee on 6 March 2023 and then by the full Council on 23 March 2023.

In this submission "Urbis report" refers to their report dated 11th November 2022 project reference P0043655 by Urbis Heritage planning lodged on behalf of the church.

We support the recommendation for heritage listing.

1 Heritage is only about one thing: significance.

This landmark site has significance in the following areas:

(a) Architectural. It was designed Fowell, Mansfield and Maclauren. They have been described as "key practitioners" in post-war (1940-60) ecclesiastical design by Richard Apperley in "Identifying Australian Architectural Styles ...".

Fowell was a prominent architect. See https://en.wikipedia.org/wiki/Joseph_Charles_Fowell

It is highly intact and in excellent condition with a high degree of integrity. It considered to be a fine and representative example of that firm's ecclesiastical buildings. The church building is described as an "interesting example of a Greek Orthodox War Memorial Church, which combines elements of the Byzantine style typically associated with an ANZAC memorial within the traditional Greek Orthodox Church style". It incorporates simple and restrained design elements of these styles. The traditional west front derived from Romanesque architecture, the bell tower with open top cupola and the traditional triple-arch entry. As the Urbis report concedes, "it is a modern building based on traditional form consisting of blonde face brick, concrete detailing and an entry triptych of three large concrete classical arches painted white over the large panelled timber front entrance doors. It features a brick campanile bell tower with rendered open cupola and free-standing cross atop the cupola. Internally, the church ceiling is a triple-vaulted timber board ceiling. The iconography and other liturgical elements are certainly not understated."

The interior of the church also incorporates a blend of traditional Greek architecture, Byzantine influences and the spiritual symbolism of the Orthodox faith in terms of iconography and distinctly Orthodox decoration.

It is a richly decorated interior incorporating candlesticks, chandeliers, icons, frescoes, a reredos, banners, lecterns and crosses and other items of opulent decoration in gold. It is not "modest and austere" as claimed by the church's Urbis report and "not readily recognisable as a Greek Orthodox Church particularly as the eastern orthodox tradition."

The Urbis report claims "the church is undecorated" p 915/998 https://www.woollahra.nsw.gov.au/__data/assets/pdf_file/0019/272422/EP-Agenda-6-Mar-2023.pdf. We disagree.

Urbis claims the site "does not exemplify any significant architectural style" p 885 of 998 and "is not a representative example of the work of the architect". **We disagree.**

(b) Social. The NSW Governor The Hon Margaret Beazley AC KC has said at the building's 60th Anniversary last year "... as a place in our community ... three things were of particular importance. The first is community ... Also ... commemoration because it is a church ... dedicated to service [of] people ... The Church is significant for its association with migrant communities that settled in NSW following World War II. Since its construction and consecration, the church building has been the focus for worship and the continuity and celebration of Greek customs and traditions in Sydney's Eastern suburbs."

It is assumed the St George Greek Orthodox Church is held in high esteem by members of the Parish and the broader Greek Orthodox community of Sydney because, apart from its regular Sunday church services, the building has been a focal point for the local Greek Orthodox community for significant celebrations and events including weddings, baptisms, funerals and religious activities for more than five decades, thereby providing an important part in the community's sense of place.

According to the Parish's own website, St George Rose Bay is now a community of over 2000 Orthodox Christians in the eastern suburbs of Sydney.

The Urbis report claims "it is undetermined if it has social significance. See p 885 of 998 https://www.woollahra.nsw.gov.au/__data/assets/pdf_file/0019/272422/EP-Agenda-6-Mar-2023.pdf.

We disagree: its social significance is confirmed.

-) (c) Historical. The site is a war memorial and was dedicated in 1962. On 24 November 1962, the Governor of NSW declared the Church as a war memorial dedicated to the memory of Australian soldiers of Greek origin who laid down their lives for Australia in the two world wars and to Australian servicemen who died in Greece during World War II. It is listed on the NSW War Memorial register and is therefore *a priori* a heritage item.
- The Urbis report claims the ANZAC plaque does not have a substantial role in the dayto-day use of the church see p 915 of 998
 https://www.woollahra.nsw.gov.au/__data/assets/pdf_file/0019/272422/EP-Agenda-6-Mar-2023.pdf. We disagree. This statement fails to properly understand the commemorative role of the plaque set into the very fabric of the church in a prominent position as an inchoate part of the site. It is a day-to-day reminder of the sacrifice of those who died and for whom the church was originally constructed.

As part of the Rose Bay Estate subdivision of the former Point Piper Estate, the St George Greek Orthodox Church and war memorial have local historical significance. The Urbis report claims "[the church] does not reach the threshold of local significance" pa 917 of 998.

We disagree for the reasons listed above.

The Urbis report is misconceived and fundamentally flawed.

The church claims it needs to demolish the church for expansion and heritage listing will thwart its aims.

This view misunderstands **the role of heritage listing.** Heritage listing does not fossilise a site. It provides a framework for alterations and adaptive re-uses which will protect its significance for future generations.

After all, this site does not belong to the church or any one group: we belong to it.

Item R2 of the Woollahra Council meeting dated 6th March 2023 notes that the site's heritage values are recognised by the Woollahra Local Planning Panel [p365 of 998 on-line edition].

We agree with those conclusions and recommend the site complex and its setting for heritage listing.

We wish to address council when this matter comes to council.

Dear Mayor and Councillors,

The Parish of St George Church, represented by the church council, wishes to reiterate the position that the Parish has taken the position to oppose the heritage listing of the Church building.

We would like to emphasize that the heritage listing of the building of the Parish of St George, will not benefit the community but will rather constrain the growth of the Parish, and will have a negative impact on the local community. We request that our future needs are considered, allowing us to make changes to the church building as our future congregation changes.

The St George community does not believe that the Parish is linked to the fabric of the church building. There is a significant social and community aspect of attending church, lifelong friendships are formed, comradery and a general feeling of belonging, when attending church. This community benefit cannot be heritage listed. The community benefit is not contained in the bricks, mortar, or design of the building but rather, the bricks and mortar surround the social significance. What occurs inside our church building, in our church hall, or on our church grounds is the glue that binds the community, not the glass or timbers or bricks from which the building has been constructed. The community and social benefit to the Parish is intangible, and cannot be heritage listed.

If Woollahra Council proceeds with the heritage listing of the St George Church building, the St George community would insist that certain items with <u>very significant religious</u> <u>value and meaning</u>, be excluded from the heritage listing. These items would need to be confirmed with our Parish Priest Fr Gerasimos, and as a minimum, include the Holy Altar table and church iconography.

For the above reasons, we kindly request that the council does not proceed to heritage list the church building.

Both my brother and I were christened at the church in 1967 and 1966 respectively, I was married at the parish, my two sons were also christened at the parish and both my parents funerals were conducted at the parish.

My love and passion for St George Rose Bay parish goes beyond being a parishioner – I have been a member of the Board of Directors for the last 11 years and 6 of those as Board Secretary.

With respect to the Proposed Heritage Listing of St George, Rose bay I would like to **SUPPORT** this proposal 100%.

The transformation of the interior aspect of the church has been subtle, tasteful and respectful of the gorgeous historical bones and detailing however, in the last few years, tasteless ornate additions have ruined the original ambience and character. Additionally, there has been mention by the Parish Priest of moving internal walls, changing the internal and external paint colour (please refer to attachments), removing the stunning wood panelling on the side walls, hanging icons by nailing into this majestic wood panelling and removing the intricate wood panelling on the ceiling and replacing with masonite.

As it currently stands architecturally and aesthetically, I believe St George Church, Rose Bay is one of the most elegant and majestic Greek Orthodox places of worship in New South Wales. Every detail within the original church has been thoughtfully considered, selected and applied to create a resplendently elegant interior and exterior.

I am a parishioner of the St George Greek Orthodox Church at Rose Bay, and a member of the parish and reside in Rose Bay. I am also secretary of the Joint Committee for the Commemoration of the Battle Crete and the Greek Campaign. The Joint Committee research, educates and commemorates Australians that served on mainland Greece and on the island of Crete in World War II and Australians of Greek Heritage that served Australia in all conflicts. St George Greek Orthodox Church was created over 60 years ago by a nascent but visionary Greek Australian Community and was dedicated as a War Memorial in memory of the Australians that lost their lives in Greece and to Australian's of Greek heritage that served Australia.

The Waverley and Woollahra Local Government Areas are essentially the region of the Parish of St George Greek Orthodox Church.

The Church is identified in the Australian War Memorial Places of Pride https://placesofpride.awm.gov.au/memorials/266053

St George Greek Orthodox Church at Rose Bay is also registered on the NSW State War Memorial Register <u>https://www.warmemorialsregister.nsw.gov.au/content/st-george-greek-orthodox-church</u>

This submission is made in favour of the proposed heritage listing of the church .

Hundreds of families from the Parish area had members that served in the Battle of Crete and the Greek Campaign in WW2 and in WW1 through the Greek island of Lemnos and the Salonika Front . I have attached a spreadsheet of my preliminary findings so far . It includes Army , Airforce and Navy personnel and Nurses . Some of them served in WW1 & WW2

In early April 1941, the 2nd Anzac Corps was formed in Greece . The 1st Anzac Corps was formed in 1915 at Gallipoli and the Greek island of Lemnos played a crucial and important role serving as the training ground , Hospital Base, Safe Harbour, and supply hub . Some 1686 Australians and New Zealanders from WW1 and WW2 were lost in Greece and over half were never found or their remains identified . These Australians from both World Wars lie in the Commonwealth War Grave Cemeteries at Athens , Crete , Lemnos , Rhodes ,Thessaloniki and regional Macedonia . I have attached to this submission Australians lost in Greece from the

Waverley and Woollahra Local Government Areas .

Many Australian service personnel also became prisoners of war, so Greece was the last place that they experienced in freedom before capture and confinement for years captive in the cold and cruel Stalag Prisoner of War camps .

In addition, some 2,500 Australians of Greek Heritage served Australia in WW1 & WW2 .

After both wars , Australians that served in Greece and their families met the new Greek Australian community.

This mutual connection of Australia with Greece through these military ties inspired the founders of St George Greek Orthodox Church to dedicate it as a War Memorial. Even the Governor of New South Wales Sir Eric Woodward, who opened the church in 1962 served in Greece in World War II. The Governor's mention and the dedication of the war Memorial is inscribed in the bronze plaque located to the right of the entry stairs.

St George Greek Orthodox Church was created by a Greek Australian community some of which came pre-WW2 and others post WW2. The architecture is a modernist approach with a restrained Byzantine Orthodox style reflecting a desire to make Australia home whilst also reflecting their Greek Orthodox heritage. This community adapted from the start and was a pioneer in using the English Language in its services and in communication with parishioners.

From the Flemish Bond face brickwork topped by the bright white bell tower to the clean interior , the building is a fusion of Greek and Australian building elements reflecting a modern society.

Many parishioners have approached me and expressed support of the proposal to list the church as a heritage item .

Should the Heritage listing be made ,St George Greek Orthodox Church will be the first purpose built Greek Orthodox Church, that comes under the auspices of the Greek Orthodox Archdiocese of Australia to be listed as a Heritage Item .

The Parish committee opposes the heritage listing of the church . It's a decision made without consultation to its members , and a petition seeking opposition to the heritage listing has been circulated electronically all over Sydney containing a negative argument against Heritage without outlining the alternative positive heritage listing benefits .

I respectfully request the council to ignore this one-sided petition in its deliberations as it is not reflective of the considered views of the Parish Community .

The heritage listing would prevent future unsympathetic alterations and will protect the integrity of the design vision of the founding community ensuring the Church's continuance in a respectful way. Should any future modifications alterations, additions be required the Heritage listing would not necessarily prevent them but ensure that such addition/ alterations are carefully considered and respectful to the original design intent.

A Heritage listing will positively enhance the building's longevity .

My only request is that should the church be listed as a Heritage Item and in the future is abandoned then the Holy Relics of the church should be allowed to be removed in accordance with the Greek Orthodox Rites .
