Public Exhibition of Planning Proposal PP-2024-2040

New Heritage Items and Heritage Conservation Areas recommended in the Wingecarribee Community Heritage Study 2021-23

On 7 August 2024 Council resolved to proceed with a Planning Proposal to implement the recommendations of the Wingecarribee Community Heritage Study 2021-23, as adopted. On 26 June 2025 the NSW Department of Planning, Housing & Infrastructure issued a Gateway Determination to progress the Planning Proposal to public exhibition (with modifications). The planning proposal is now on public exhibition in accordance with the Gateway requirements and submissions are sought from the community.

EXHIBITION DATES: The planning proposal is on public exhibition for a period of 40 days from **22 October to 30 November 2025**, inclusive.

All submissions must be received on or before **30 November 2025** quoting reference PP-2024-2040.

Submissions may be viewed by a third party and will be reported to Council, although they will be redacted to remove personal details before being published.

All submission makers will be notified when the Planning Proposal is being reported back to the Wingecarribee Local Planning Panel and to Council with details of how to speak to the matter if so desired.

Council has not been given delegation to finalise the Planning Proposal. Therefore, following Council adoption it will be resubmitted to the Department of Planning, Housing and Infrastructure for finalisation.
