12.1.1.Planning Proposal to amend the heritage listing for 83 Fitzwilliam Road, Vaucluse

THAT Council:

A. Note the advice provided by the Woollahra Local Planning Panel on 19 September 2024 regarding the planning proposal to amend the local heritage listing at 83 Fitzwilliam Road,

Vaucluse to include the dwelling/former shop (including interiors), and associated landscape elements.

- B. Endorse the planning proposal as contained at Attachment 1 of the report to the Environmental Planning Committee of 25 November 2024 to alter the listing for local heritage item I357, subject to amending the description of the item to be as follows: "Vaucluse Point Ferry Wharf" remnants of wharf, dwelling/former shop exteriors, excluding the interiors, but including the internal staircase and associated landscape elements at 83 Fitzwilliam Road, Vaucluse (LOT: 100 DP: 1304245), in Schedule 5 of the Woollahra Environmental Plan 2014 and resolves to forward this to the Department of Planning, Housing and Infrastructure with a request for Gateway Determination to allow public exhibition.
- C. Request the Minister for Planning and Public Spaces (or delegate) authorise Council as the local plan-making authority in relation to the planning proposal, to make the local environment plan under section 3.36 of the Environmental Planning and Assessment Act 1979.
- D. Request the applicant to provide a commemorative plaque at street-front.
