Hi Luke,

Thank you for reaching out in regard to Georges Cove Marina – RZ-5/2018 (Amendment 86) and Georges Cove Village – RZ-9/2017 (Amendment 87).

In short – it is up to Council if they want to submit a PP to Gateway for assessment. My only advice is that the proponent should do the following:

- Address the findings of the Flood Inquiry findings
- Address the draft shelter in place policy

Furthermore, the Moore Point PP was dealt with on a merit based process and does not create a pathway or process for other PPs affected by flooding. The Department and the NSW Reconstruction Authority are working on a range of programs, policy changes and guidance to proactively plan for and mitigate against the impacts of floods. The work supports the adoption of a risk-based approach to flood planning and is intended to ensure that floodplains can be safely enjoyed to their full social, environmental, cultural and economic potential (in line with the recommendations of the independent 2022 Flood Inquiry).
