1 PLANNING PROPOSAL – NEW EMPLOYMENT ZONES

Panel Assessment

CBLPP Recommendation

The Panel generally supports Councils approach to the implementation of the new Employment Zones. However, the Panel considers that the current permitted uses in the IN2 zone should be permitted in the new E4 zone. These uses include:

Animal boarding or training establishments; Landscaping material supplies; Plant nurseries; Recreation facilities (indoor); Timber yards; Veterinary hospitals; Wholesale supplies.

In allowing a broader range of uses in the E4 zone the Panel recommends that the DCP contain adequate provisions to address potential impacts and mitigation of impacts at interfaces with other zones.

Subject to the above change the Panel supports the Planning Proposal proceeding to gateway.
