This memorandum provides a high-level needs analysis of the potential for a Medical Centre at Mortdale Plaza, located at 84D Roberts Ave, Mortdale NSW (the subject site), including current and projected population, supply of medical provision and comparison to benchmarks.

Context

The subject site is located approximately 15 kilometres west of the Sydney Central Business District and within the Georges River Local Government Area (LGA). According to the Australian Bureau of Statistics Census, the LGA population was 152,274 in 2021, with key occupations across the region including professionals, clerical & administrative workers, managers & technicians and trades workers.

Mortdale Plaza is a Neighbourhood Shopping Centre constructed in 2015, spanning 3-floors and hosting a Woolworths supermarket, pharmacy, liquor store, gymnasium, child care centre and various speciality offerings.

A Planning Proposal is seeking to amend the Georges River Local Environmental Plan (GRLEP) to permit the development of a Medical Centre within Mortdale Plaza by updating Schedule 1, Cl.5 (2) to include a 600 sq.m Medical Centre.

Catchment and population

The extent of the catchment is shaped by the interplay of a number of critical factors. These factors include:

- The relative attraction of the subject site, specifically its scale and composition, layout and ambience, car-parking and access/ease of use.
- The proximity and attractiveness of competitive provision. The locations, compositions, quality and scale of competitive facilities all serve to define the extent of the catchment which the subject site is effectively able to serve.
- The available road network and public transport infrastructure, which determine the ease (or difficulty) with which customers are able to access the subject site.
- Physical barriers which are difficult to negotiate and can act as delineating boundaries to the catchment.

The catchment (refer Map 1) is defined to include the subject site and surrounding suburbs of Peakhurst, Peakhurst Heights and Lugarno, along with parts of Riverwood, Penshurst, Beverly Hills, Mortdale, Oatley and Narwee, defined by their Australian Bureau of Statistics Statistical Area 2 (SA2) boundaries. Within the catchment, the population is estimated at 70,000 at the 2021 Census and is expected to grow to 70,161 by 2026 and 76,682 by 2031.

Medical Centre supply

Table 2 shows the current and projected supply of General Practitioner (GP) based medical providers within the catchment, sourced from Health Direct. The catchment consists of 17 providers totalling 46 GP's, with one potential future centre found, currently at the development approval stage and with the site listed as for sale.

Benchmarking and potential

Table 3 provides a comparison of the provision of GP's per population in the catchment at 2022 to benchmarks provided by the Department of Health and Aged Care GP Workforce Statistics. Across Australia the benchmark is 115.1 GP's per 100,000 population, compared with 119.2 and 119.0 for New South Wales and metropolitan areas respectively. The catchment has an estimated 2022 population of 70,032 residents and 46 GP's, representing 65.7 GP's per 100,000, significantly below all benchmarks.

Table 4 provides an assessment of the number of GP's required over the forecast period, and an estimate of the over/undersupply based on the Australian metropolitan benchmark in Table 3 and assuming the potential Medical Centre in Table 2 is developed.

The analysis estimates that in 2021 there was an undersupply of 18 GP's within the catchment, and this undersupply is projected to continue over the forecast period.

Potential employment outcomes

The proposed Medical Centre will support an increased level of employment both directly onsite and indirectly in the wider economy.

Using industry employment densities and our own view of appropriate benchmarks, an employment density of 31.7 sq.m per worker is estimated for a Medical Centre provision at the subject site, suggesting the proposed 600 sq.m can support 19 Full Time Equivalent (FTE) jobs. With regard to the undersupply of GP's in the catchment, the planned scale of development and employment density outcome, we believe that there is support for 3 - 6 GP's at the subject site.

The direct operational employment will also flow through to indirect employment elsewhere in the local economy that supports onsite employment. The ABS I-O simple employment multipliers indicate that every 1 direct health/medical FTE job will generate another 0.2 indirect supporting FTE jobs (production induced) elsewhere in the economy, including professional, scientific and technical services, transport, postal and warehousing, rental, hiring and real estate services, administrative and support services, manufacturing, and other industries. Using this benchmark, an estimated 4 additional jobs could be created elsewhere in the local economy.

Table 5 summarises the above medical centre job projections, and those of the current Mortdale Plaza retail and supporting non-retail uses, assuming typical vacancy rates seen in comparable centres. There is estimated to be 176 FTE jobs in the current centre, with an increase to 211 jobs (+20%) including the imminent opening of a childcare centre and the proposed medical centre.

Summary

The key conclusions drawn from this analysis are as follows:

- There is an undersupply of Medical Centres and General Practitioners within the catchment.
- 19 FTE jobs could be created by a Medical Centre development at the subject site.
- 2 5 General Practitioners could be supported.
- 4 additional jobs could be created in the local economy.
