## SUBJECT Draft Amendment 23 to Blue Mountains LEP 2015 - The Clarendon and Heritage Housekeeping

We write seeking a Gateway Determination for the planning proposal for draft Amendment No. 23 to Blue Mountains LEP 2015. The purpose of this planning proposal is to list one item, The Clarendon, as a heritage item under an Interim Heritage Order, and to modify the details of thirteen other existing heritage items to correct minor, non-significant errors.

At its meeting of 28 January 2025 (Minute 12) Council resolved:

- 1. That the Council endorses the draft Planning Proposal, prepared in accordance with section 3.33 of the Environmental Planning and Assessment Act 1979, for Blue Mountains Local Environmental Plan 2015 Amendment 23 (The Clarendon and Heritage Housekeeping) be submitted to the Department of Planning, Housing and Infrastructure (the Department) requesting a Gateway Determination (Enclosure 1);
- 2. That the Council notes the advice provided by the Local Planning Panel on the draft Planning Proposal for Blue Mountains Local Environmental Plan 2015 Amendment 23 (The Clarendon and Heritage Housekeeping);
- 3. That the Council processes the Planning Proposal in accordance with the Gateway Determination issued under the provisions of Section 3.34 of the Environmental Planning and Assessment Act 1979;
- 4. That the Council receives a report, subject to Gateway Determination and at the conclusion of the public exhibition period, to enable consideration of submissions made to the draft Planning Proposal for Blue Mountains Local Environmental Plan 2015 (Amendment 23); and
- 5. That the Council delegates to the CEO or her delegate the authority to make minor amendments to the adopted draft Blue Mountains Local Environmental Plan 2015 (Amendment 23) that may arise after the formal adoption by the Council of this planning proposal, subject to such amendments maintaining the policy intent of the draft planning proposal.
