**Moved** David McGowan, seconded Allen Grimwood that the proposed development be refused and the following points be added to the reasons for refusal:

- The proposed development is inconsistent with the objectives of the 6(b) Private Recreation zone under the Wollongong Local Environmental Plan 1990 and the objectives of the RE2 Private Recreation zone under draft Wollongong Local Environmental Plan 2009 which are primarily intended to ensure the land is developed for open space and recreation purposes.
- The proposed use is a prohibited use under the provisions of the exhibited Draft Wollongong Local Environmental Plan 2009 and weight should be given to this intention and the exhibited status of the draft Plan.

ITEM 2 - 2009STH011 - Wollongong - DA-21128843, - Demolition of existing building and construction of academic and research building in two stages - Lot 6 Northfields Avenue, Keiraville

The Chairperson tabled a letter from WCC Administrators indicating support for the recommendation for approval with conditions.

The Panel expressed their concerns at the long term traffic problems experienced throughout the nearby area due to lack of transport and car parking on site and of their support for alternative means of transport.

<u>Additional Condition</u>: a review of the Transport Strategy and Implementation Plan be carried out to determine the effectiveness of alternative forms of transport and that the results be endorsed by Wollongong City Council, the University of Wollongong and the RTA to demonstrate demand and supply for transport, prior to issue of the construction certificate.
