- 8. condition 22 change 'watching brief' to 'monitoring'
- 9. condition 24 moved to advisory notes.
- 10. condition 67 delete except for (d) which becomes a new condition.
- 11. condition 69 deleted. Council's traffic engineer to meet with the Applicant's traffic consultant.
- 12. condition 73 to be provided prior to the issue of a Construction Certificate for the basement car park.
- 13. condition 81 deleted
- 14. condition 112 deleted and contents added to the Conservation Plans condition.
- 15. condition 123 moved to advisory notes.
- 16. condition 124 deleted
- 17. condition 16 delete the words 'not' and 'until' in the first line of the condition.
