ITEM 1 - 2009HCC004 – Lake Macquarie DA /1297/2009 - Stage 14 North Wallarah Subdivision, 2 Lake Forest Drive Murrays Beach

That the Panel grant consent to the development application made by Stockland Wallarah Peninsular Pty Ltd, subject to the conditions set out in Appendix A to the Agenda and Business Paper for this meeting, as amended by the Panel as follows:

Amend first paragraph of Condition 51 to read:

51. The applicant shall engage an owl expert, as approved by Council, "the approved owl expert" to prepare and implement a Masked Owl Management Plan (the Management Plan). The Management Plan is to be generally in accordance with the recommendations set out in the letter from John Young Wildlife Enterprises Pty Ltd dated 10 May 2010 as well as advice from Dr Rod Kavanagh dated 11 January 2010. The Management Plan shall include:

Amend Condition 51 to include each recommendation set out in the letter from John Young Wildlife Enterprises Pty Ltd dated 10 May 2010 as well as the advice from Dr Rod Kavanagh dated 11 January 2010.

Amend Condition 51 to incorporate Condition 53 as an additional dot point within Condition 51.

Amend last paragraph of Condition 51 to read:

The Management Plan shall be submitted to Council for approval prior to the issue of the first Construction Certificate and all works shall be undertaken in accordance with the Management Plan. The Management Plan shall identify who is responsible for undertaking all actions identified in the Management Plan. If the Management Plan identifies any actions to be undertaken by the Community Association, the Community Management Statement shall be amended to include this responsibility. The approved owl expert shall implement the Masked Owl Monitoring Program.

Create a new Condition 53 to read:

53. Relevant recommendations of the Masked Owl Management Plan shall be incorporated into the Community Management Statement for DP 270485.

Amend heading and section referring to 'Submission for Subdivision Certificate' and Condition 58 to read:

#### Submission for Subdivision Certificates

There are requirements which must be satisfied before the Principal Certifying Authority may issue the Subdivision Certificates pursuant to Section 109J of the Environmental Planning & Assessment Act 1979 in respect of a subdivision.

58. The Applicant shall submit the Final Community Scheme to Council.

This Final Scheme is to include Location Diagram, Detail Plan, Community Property Plan, Management Statement and ten (10) copies of the Final Community Plan of Subdivision.

When all conditions of the Development Consent relating to this subdivision have been satisfactorily complied with the **Subdivision Certificates** will be issued.

#### Amend Condition 61 to read:

61. Prior to the issue of any Subdivision Certificates, a certificate of compliance under **Section 50** of the **Hunter Water Act 1991** for this development shall be submitted to the Principal Certifying Authority.

Advice: Council does not forward notification of the subdivision approval to the Hunter Water Corporation. It is the Applicant's responsibility to make all pertinent arrangements with the Hunter Water Corporation.
