New Condition 1a:

1a. Prior to the issue of a Construction Certificate, amended landscape plans shall be submitted to and approved by Maitland City Council, which demonstrate consistency with development plan *'project no. 2870, sheet DA03, revision J, dated 28.10.10, prepared by Leffler Simes Architects'.*

Amended Condition 10:

2. All landscaped areas of the development shall be maintained in accordance with the approved landscape plan. The landscaped areas shall be kept free of parked vehicles, stored goods, waste material, and the like.

<u>Note:</u> The applicant is advised that the land adjoining the site directly to the south and west (Lot 124 DP1133194) is a Council owned drainage reserve. Council will maintain in perpetuity the

landscaping proposed to be installed by the developer on the northern and north-eastern boundaries of the drainage reserve in accordance with its normal maintenance regime for public/drainage reserves. Council may grant consent to the owner (or its agents) of the subject proposal to enter the reserve to carry out maintenance from time to time if a higher level of maintenance is required.
