ITEM 1 - 2010HCC027 Lake Macquarie DA/1282/2010 - Industry - Asphalt Plan; 11-18 Billbrooke Close, Cameron Park

**Moved** by: Barry Johnston and seconded by Kara Krason that DA/1282/2010 Industry - Asphalt Plant at 11-18 Billbrooke Close, Cameron Park be refused for the following reasons:

- The amenity of the locality, including Billbrooke Close, will be adversely affected by the proposed development by reason of the development's:
  - (a) visual impact of the bulk and scale of the tower and the associated stacks;
  - (b) traffic generation in times of peak production periods;
  - (c) dust and odour generation;
  - (d) being out of character with the existing and likely future uses of the neighbourhood.
- The proposed development does not comply with Lake Macquarie City Council's Development Control Plan No. 1 Principles of Development, clauses:
  - 2.1.3 Unacceptable scenic impact;
  - 2.7.1 Scale and appearance of the proposed development are inconsistent with street character, or its desired character;
  - 2.7.6 Impact on views to the site are unacceptable;
  - 3.6.1 Environmental Performance:
    Performance Criteria 4: The proposed development adversely impacts on the visual amenity of the locality;
    Performance Criteria 6: The risks and hazards of the proposed development are not within acceptable limits.
  - 3.6.3 The proposed development's design and appearance are contrary to the existing and likely future context of Billbrooke Close.
- The likely effect of the emissions from the proposed development upon rainwater collected in rainwater tanks for domestic consumption has not been addressed.
- 4 The proposed development is not in the public interest.
- The proposed development is inconsistent with Objective 1(c) of the 4(1) Industrial (Core) zone under Clause 15 of Lake Macquarie Local Environmental Plan 2004.
