2010HCC033 Newcastle 10/1100 - New Bunnings building and outdoor areas, associated carparking, driveways and loading facilities and landscaping including 11 signs – 1A Minmi Road Wallsend The Joint Regional Planning Panel resolved that consent be granted to DA 10/1100, subject to the conditions as recommended in the assessment, subject to the following amendments to the recommended conditions:

- 1. Amend Condition A3 to restrict delivery and dispatch hours to no later than 9pm rather than 10pm.
- 2. Condition A4, regarding the emergency access onto Sandgate Road/Robert Street, to be replaced by a condition that deletes all vehicular access to Sandgate Road/Robert Street.
- 3. Amend Condition C23 to provide an additional requirement for additional mature shade tree planting in the car parking area at a rate of 1 tree per 6 parking spaces.
- 4. Amend Condition F14 to require the acoustic fence adjacent to 1 Robert Street to be relocated to a position immediately adjacent to the Bunnings access road and a the landscaped buffer be located on the southern side of this acoustic fence, with plans in this regard to be to the written satisfaction of the Council.

5. Incorporation of a new condition that requires an Energy and Water reduction report, outlining measures to reduce consumption, to be provided to the written satisfaction of the Council prior to issue of a contruction certificate.
