The Panel adopt the Council officer's recommendation to approve the proposal subject to the recommended conditions of consent, with amendments as outlined below:

(i) Condition 5 to be amended to add part (f) as follows:

5 Geotechnical

(f) A geotechnical report is to be submitted to Council addressing existing ground conditions, proposed method of excavation and construction, and proposed actions to protect against noise and vibration impacts of excavation and construction.

(ii) The following to be inserted under the heading 'Prior to the Issue of the construction certificate':

55a. A revised site plan, landscape plan and floor plans are to be submitted to Council showing a landscaping strip on the eastern boundary. Council's written approval is to be obtained prior to issue of the Construction Certificate.

55b. Revised elevations are to be submitted to Council showing treatment of openings on the eastern elevation at Ground floor and Level 1. Openings are to be of obscure glass, sufficient to maintain privacy for occupants of 44 Loftus Street. Council's written approval is to be obtained prior to issue of the Construction Certificate.
