A Waste Management Plan is to be submitted to Council for approval prior to the issue of any construction certificate for any stage of the works. A Waste Management Plan must detail storage, control and management of waste on the site and the disposal of all waste to licensed or approved disposal facilities."

viii. F1 amended to include "for the land or any part of the land"

c. The panel request Council to establish a working party including all relevant stakeholders to consider options for pedestrian traffic management in Smollett Street.

d. Council review the appropriateness of upper level setbacks of new developments subject to Albury Development Control Plan 2010 in relation to mid-block service lanes.
