# ITEM 2 2010STH036 – Wollongong – DA-2010/1562 – Demolition of existing Corrimal Leagues Club and construction of residential development comprising 60 x residential home units above basement parking and 6 x villa homes with double garages and visitor parking – 54- 62 Railway Street, Corrimal

29 c) The northern side boundary adjacent to the proposed driveway shall be constructed of brickwork to a maximum height of 1.8 metres and tapered down from the six (6) metre front building line to a maximum height of 1.2 metres at the front boundary point of Harbinger Street.

46 a) An acoustic assessment by a suitably accredited consultant shall be undertaken to identify the background noise of the Illawarra Coking Coal operations. The report shall provide construction recommendations for any required noise attenuation measures for the development which shall be reflected on the Construction Certificate Plans.

# Business Item (DA-2009/1636) Recommendation:

**Moved** D Winterbottom seconded T McCarthy that the JRPP resolve that DA-2009/1636 for a Resource Recovery Centre at Five Islands Road Cringila, be refused because:

- 1 The proposal does not conform to the objectives for the zone.
- 2 The proposal is not in the public interest.
- 3 The cumulative impact of the proposed development, the current operations on the site and potential operations permitted by DA-1993/774 would result in unacceptable amenity impacts on the surrounding environment.
- 4 The Environmental Impact Statement does not adequately address the Director General's Requirements in relation to identifying alternate sites.
- 5 The rehabilitation strategy proposed for the site does not adequately address the whole of the site and is therefore inconsistent with the Director General's Requirements and would result in an unacceptable outcome for the site.
- 6 The provision of utility services is inadequate.
