6. Business Item Recommendations

ITEM 1 - 2010SYE117 - Woollahra - DA671/2010/1 - Demolition of the existing building from ground floor level, retention of the basement carpark for 154 vehicles, construction of a mixed use development with retail tenancies and a five (5) cinema complex for approximately 600 people which occupies the ground and first floor levels and seven (7) levels of residential above containing 74 units (a mix of one, two and three bedrooms) - 33 Cross Street, Double Bay
